

## Certified Nurse-Midwife and Certified Midwife Medicaid Reimbursement Rates

The Amount of Fee-for-Service Reimbursement for CNMs and CMs under State Medicaid Programs Relative to Physician Reimbursement Rates

A State-Level Study

## **METHODOLOGY of STUDY**


This is the first product in a series of data sets concerned with Medicaid reimbursement rates for CNMs and CMs. The singular goal of this set is to accurately identify current Medicaid reimbursement rates.

Several sources were used to verify rates. Consulted sources include statutes, regulations, practitioner specific state Medicaid manuals, fee schedules, and staff at the state Medicaid offices. These sources often contained conflicting or ambiguous information and, in many states, Medicaid offices would not discuss reimbursement rates with ACNM since we lack an NPI number. Some states have managed care and fee-for-service components of their Medicaid system, which further complicated verification efforts. This study focuses on fee-for-service rates.

In an effort to further verify the rates identified by ACNM, two secondary sources were consulted: the Kaiser Family Foundation's (KFF) Medicaid Benefits Online Database and the 2012 Legislative Update published by the journal *The Nurse Practitioner*. Neither of the secondary sources were entirely ideal. The KFF Database has not been updated since 2010. The Legislative Update has, as would be expected, a tendency to focus on NPs, although for multiple states all categories of APRNs were included. In the instances when the rates identified by ACNM matched the rates published in either of these sources, it was understood to be a confirmation of the rates' accuracy. However, rates that did not match these sources were not necessarily excluded as incorrect. For example, both sources cited the reimbursement rate in North Carolina as 100% of physician levels. However, a new fee schedule was published in late 2011 that dropped CNM reimbursement rates to 97% of physician levels. Differences between ACNM research and the secondary sources may therefore be due to new developments or reliance on different types of source material.

ACNM has made every effort possible to ensure that the rates listed in this data set are correct, but it is hoped that ACNM members can help us identify and correct any inaccuracies.








