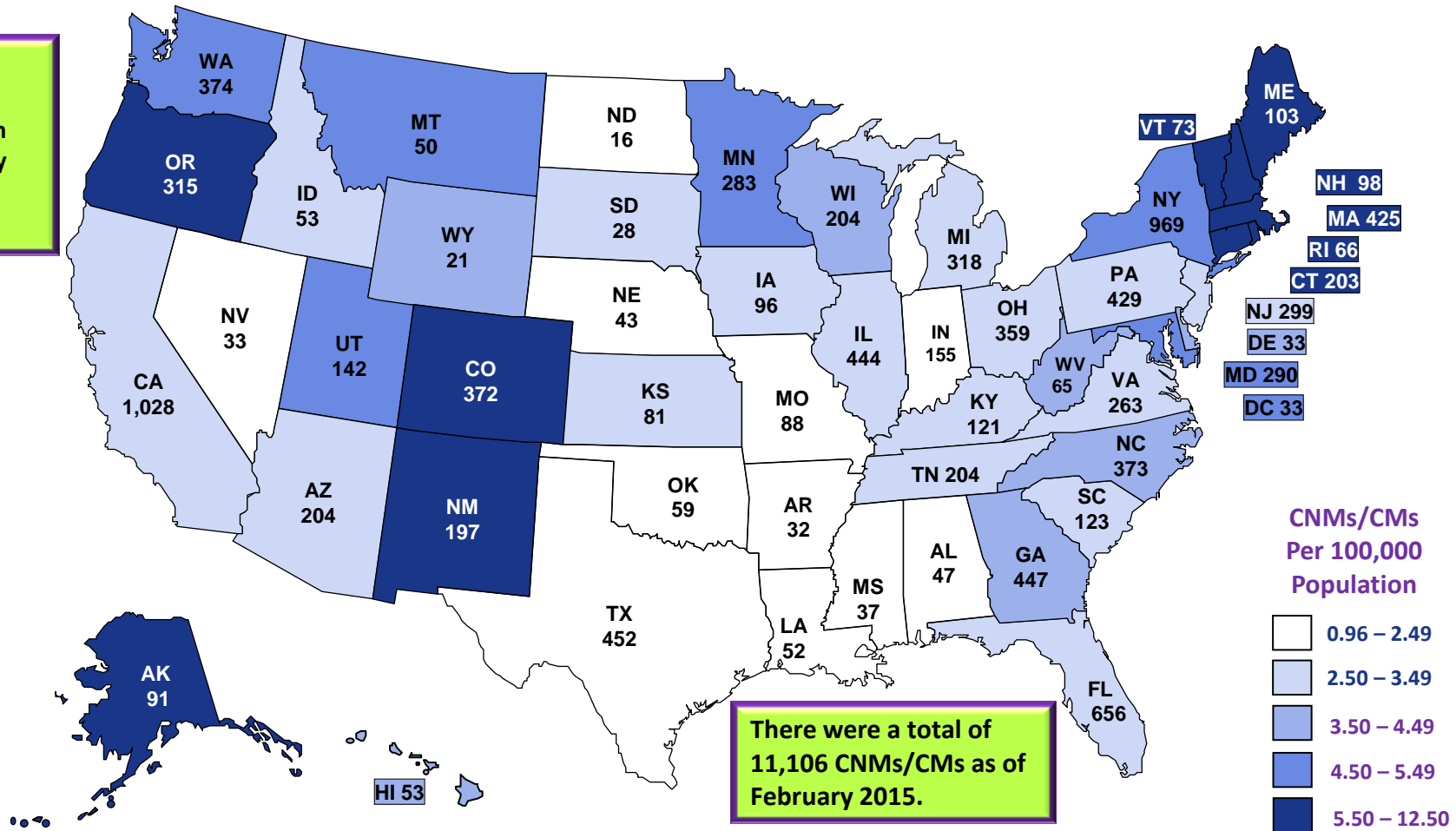

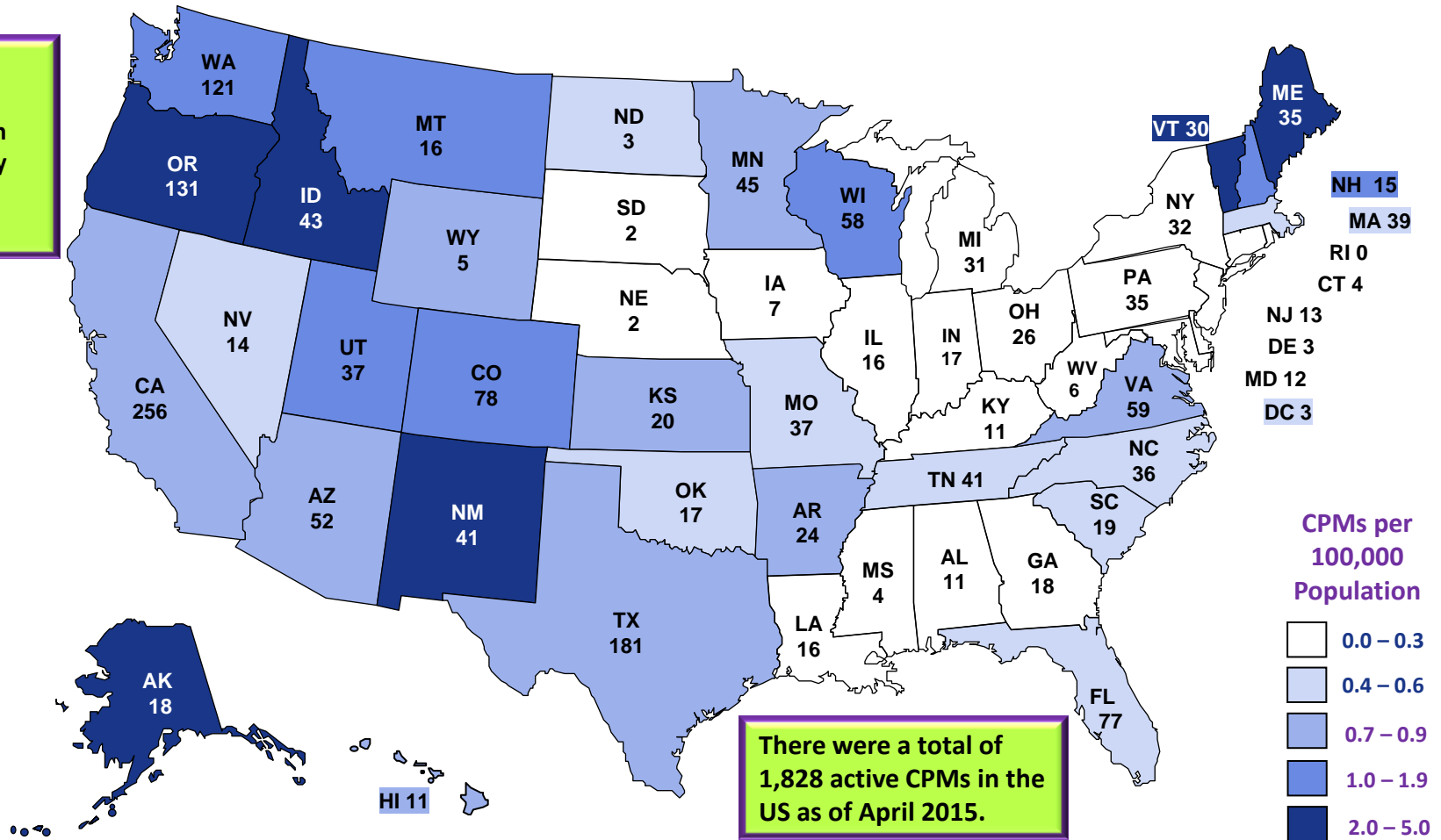

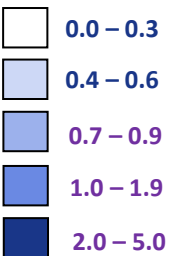

Number and Density of NARM Certificants by State – 2015

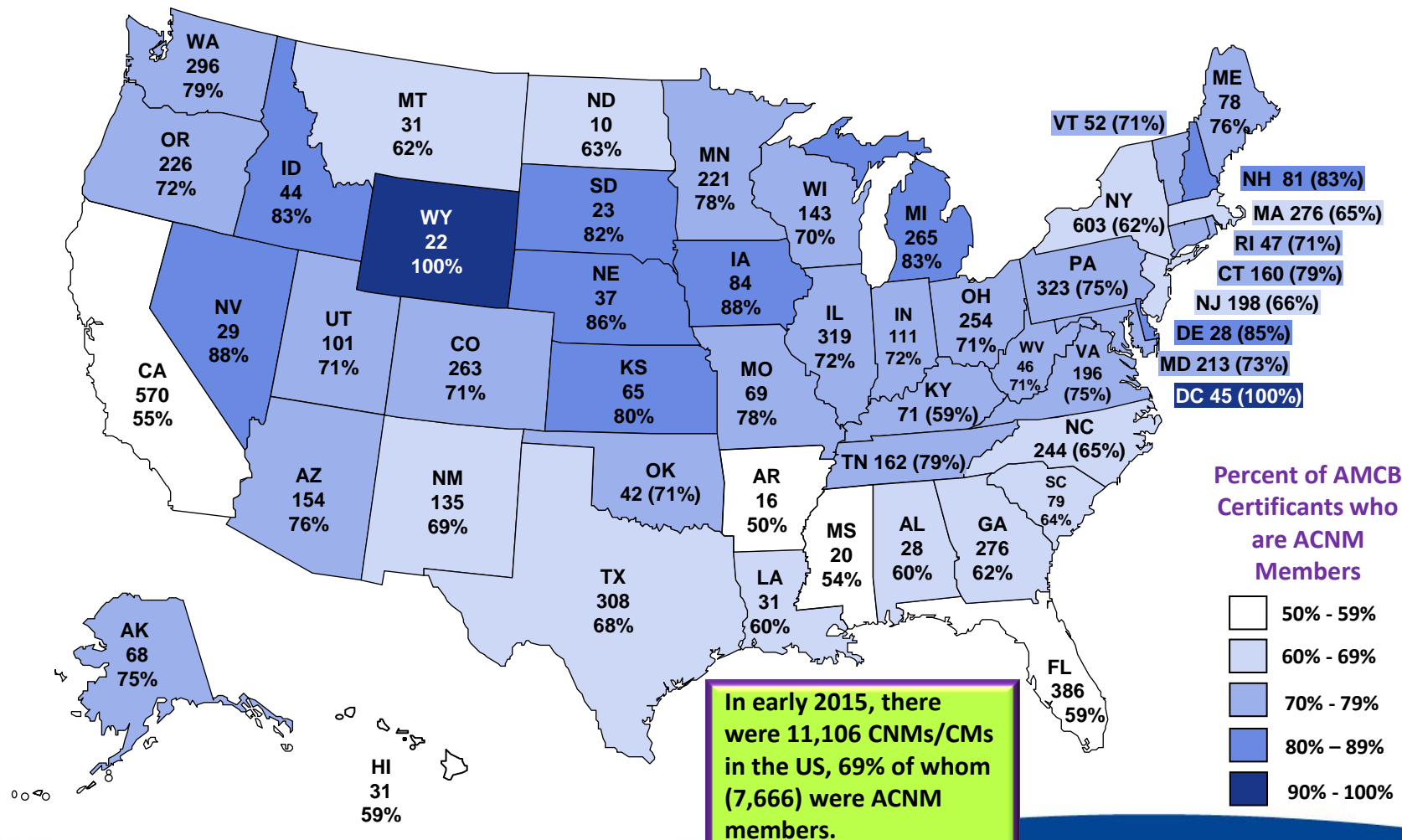

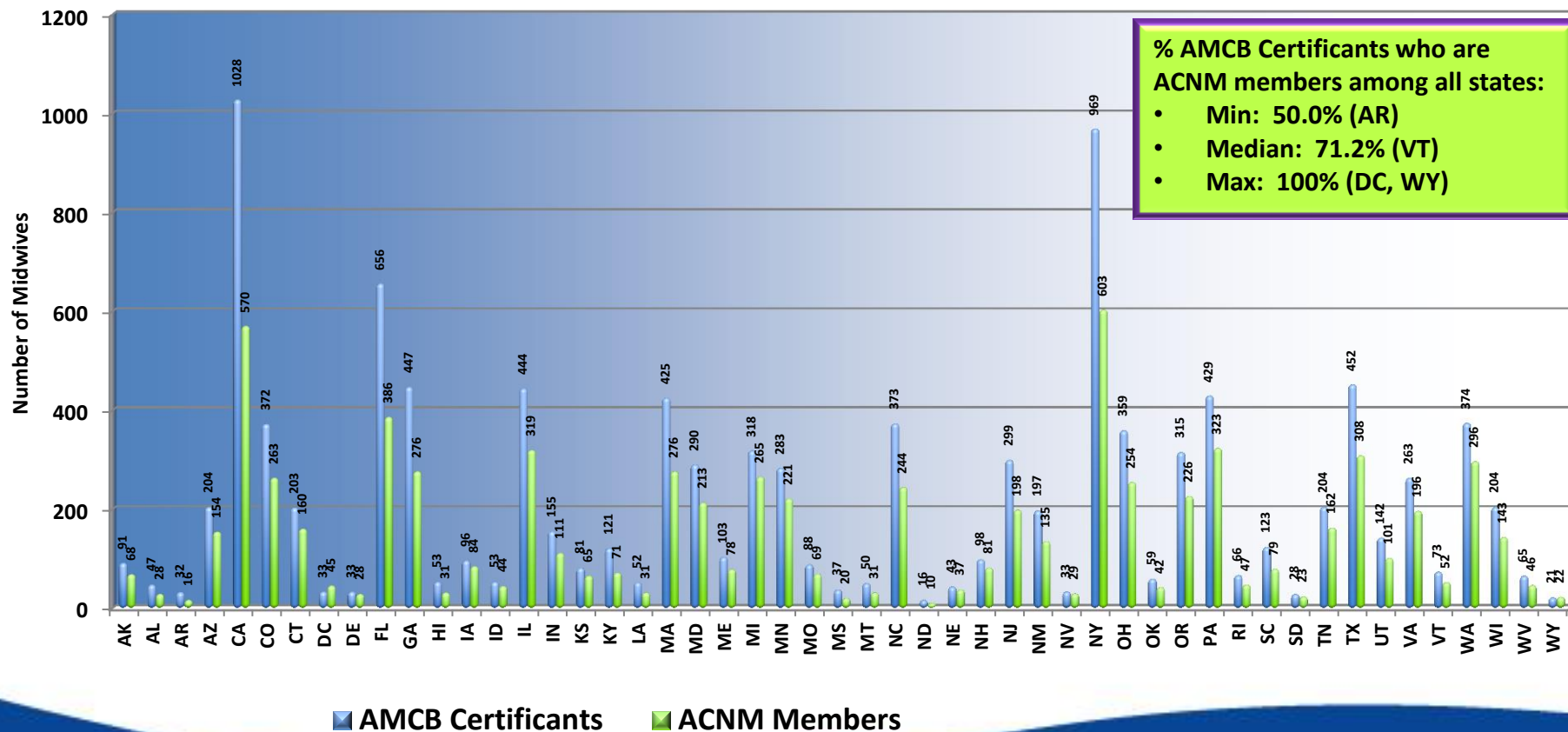
Number of ACNM members per ACNM member database (May 2015).

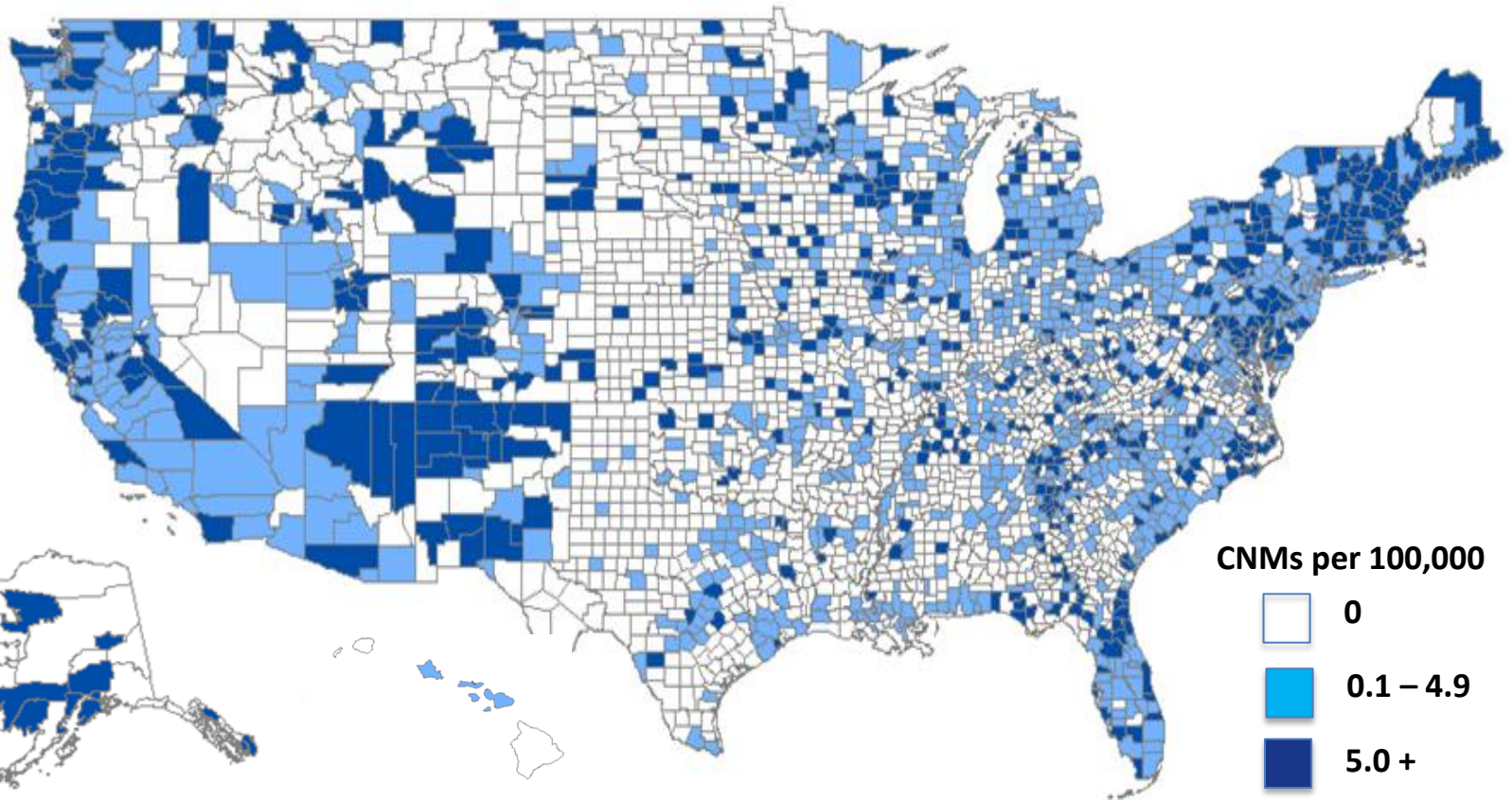
AMCB Certified Midwives vs. ACNM Members - 2015

Out of 3,142 U.S. Counties, 1,758 (56%) have no CNM.

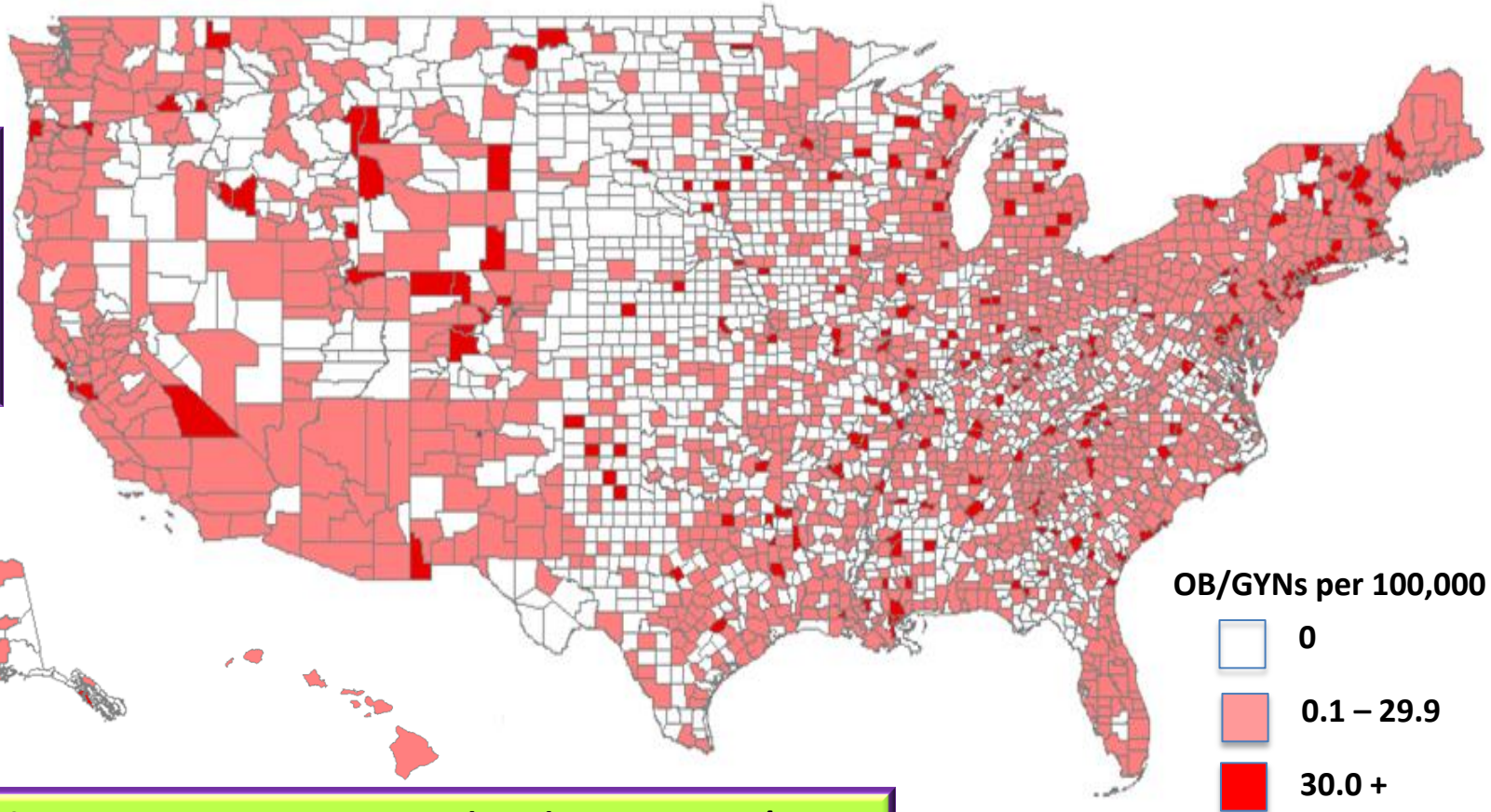

Out of 3,142 U.S. Counties, 1,459 (46%) have no OB/GYN.

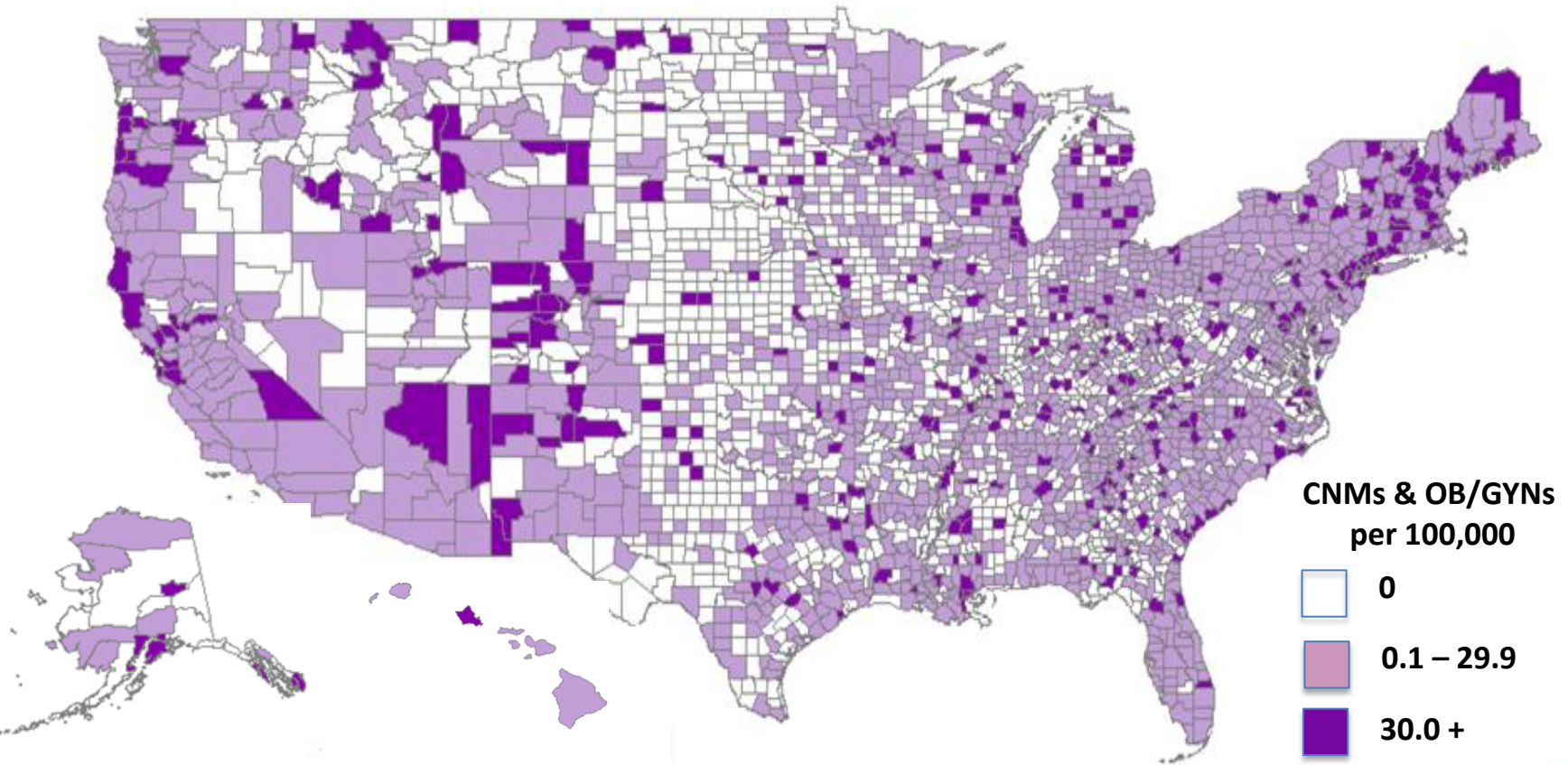

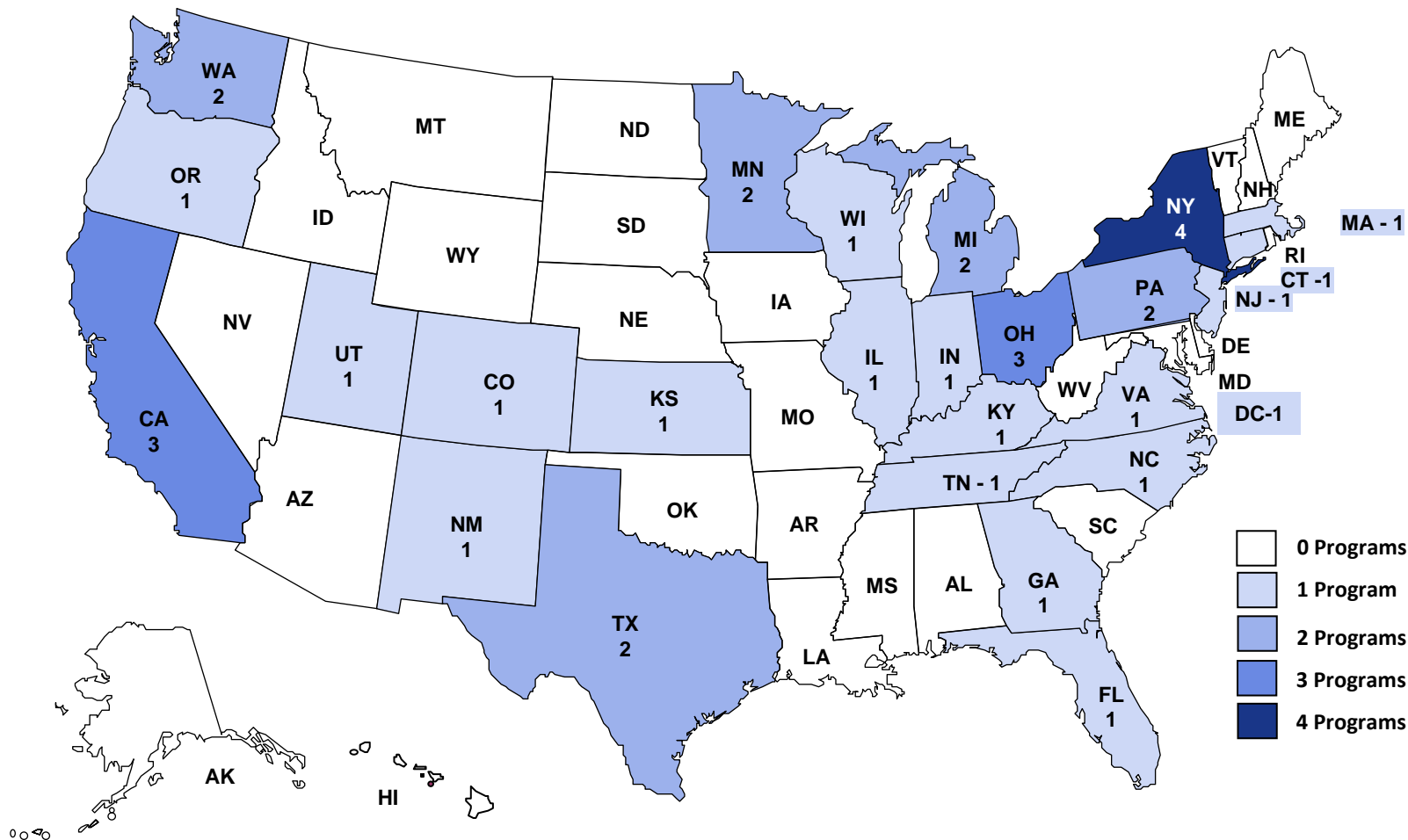

CNMs/CMs and OB/GYNs per 100,000 Population – 2011



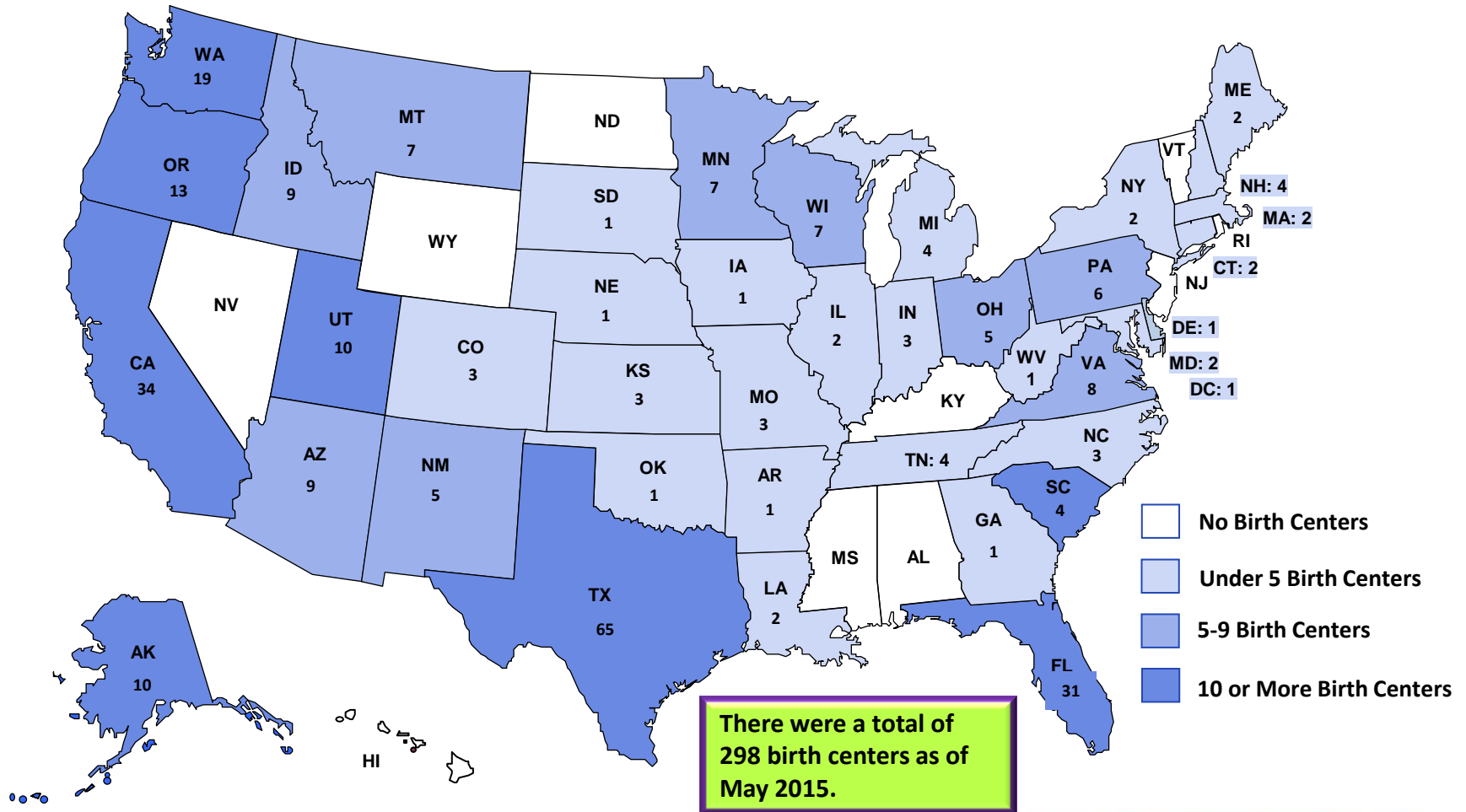

Number of Midwifery Education Programs by State – 2015



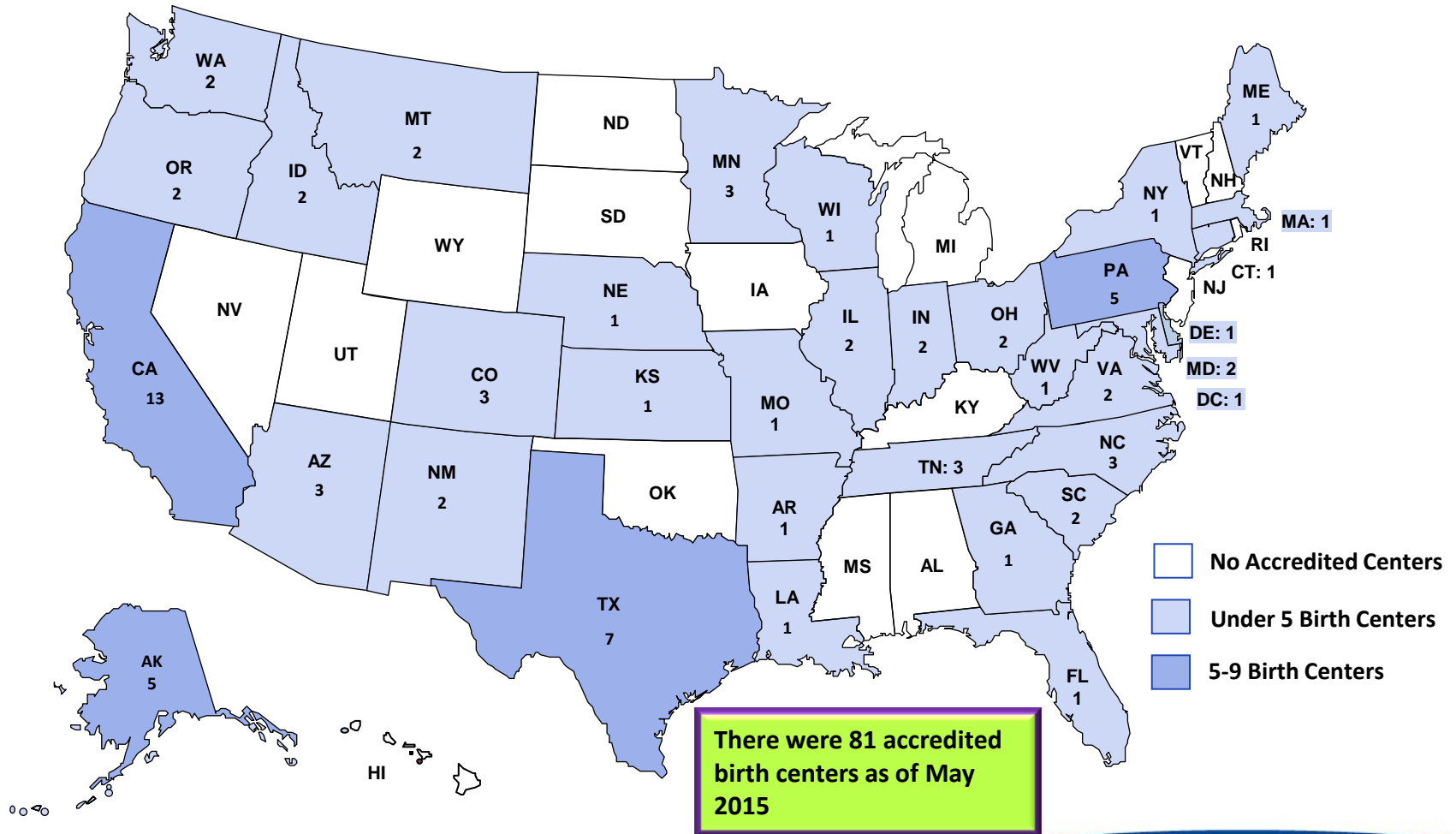
Total Number of Birth Centers per State (Accredited and Non-Accredited) - 2015

Accreditation by Commission for the Accreditation of Birth Centers (CABC); Does Not Include Pending Accreditations



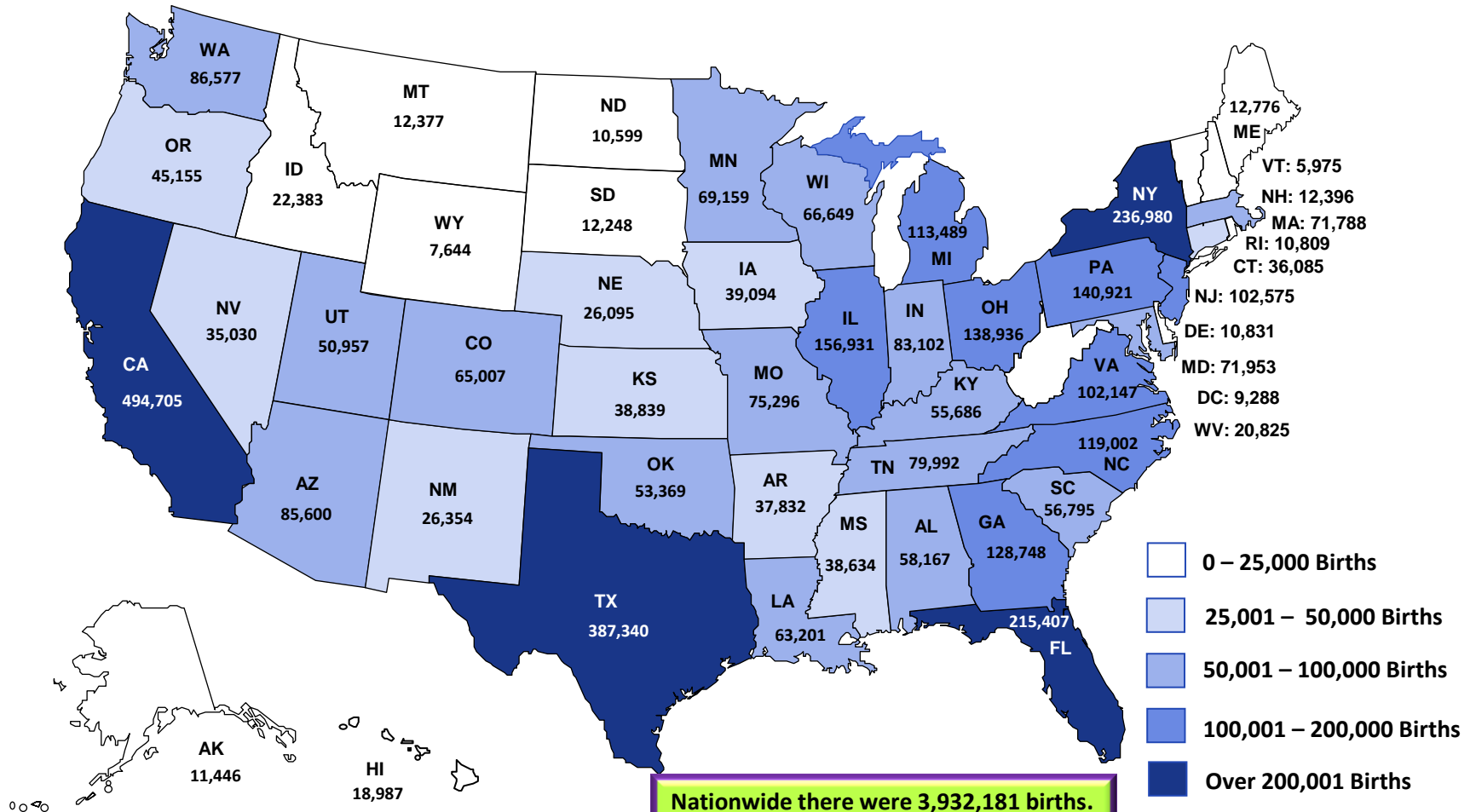

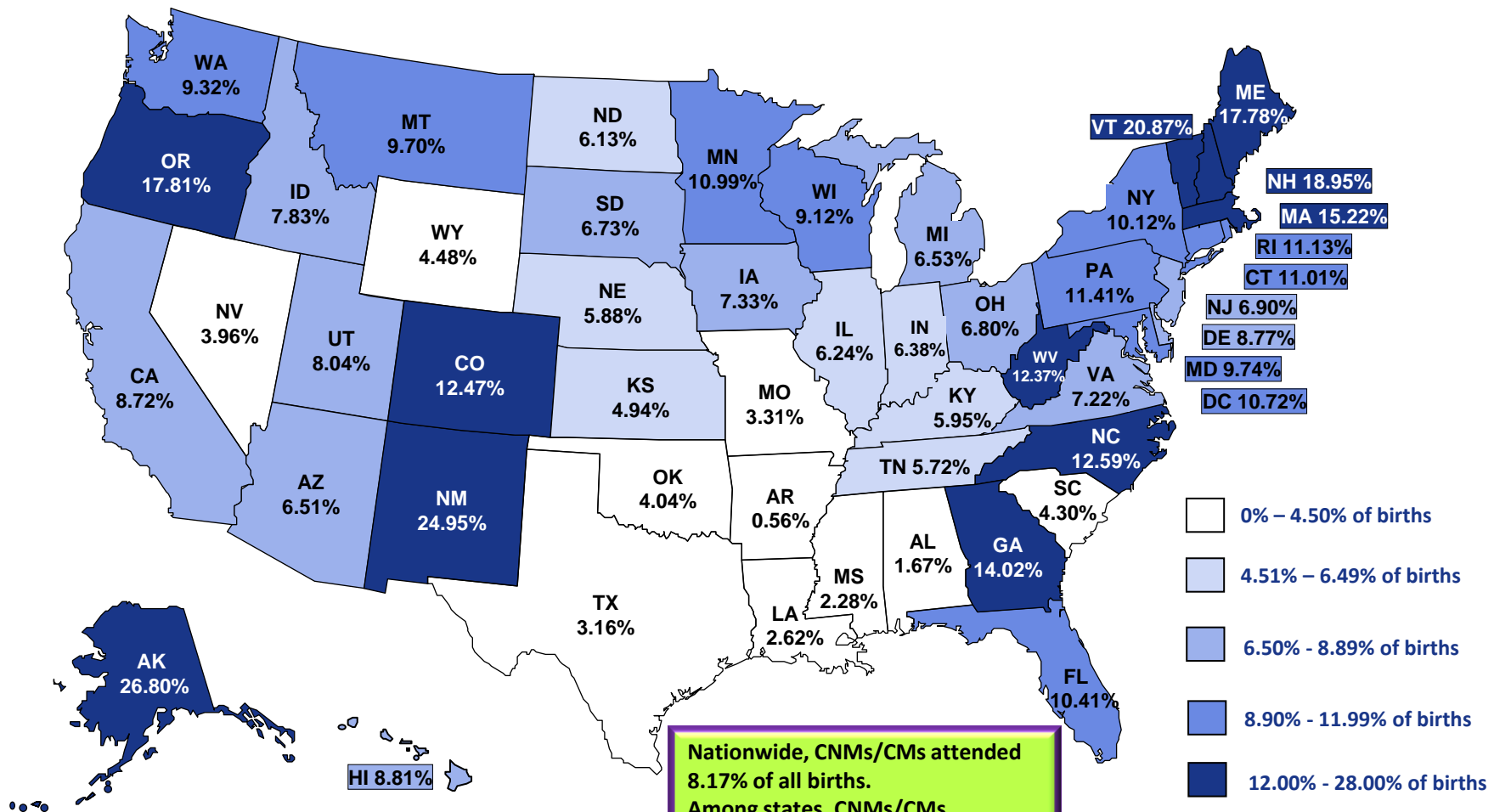

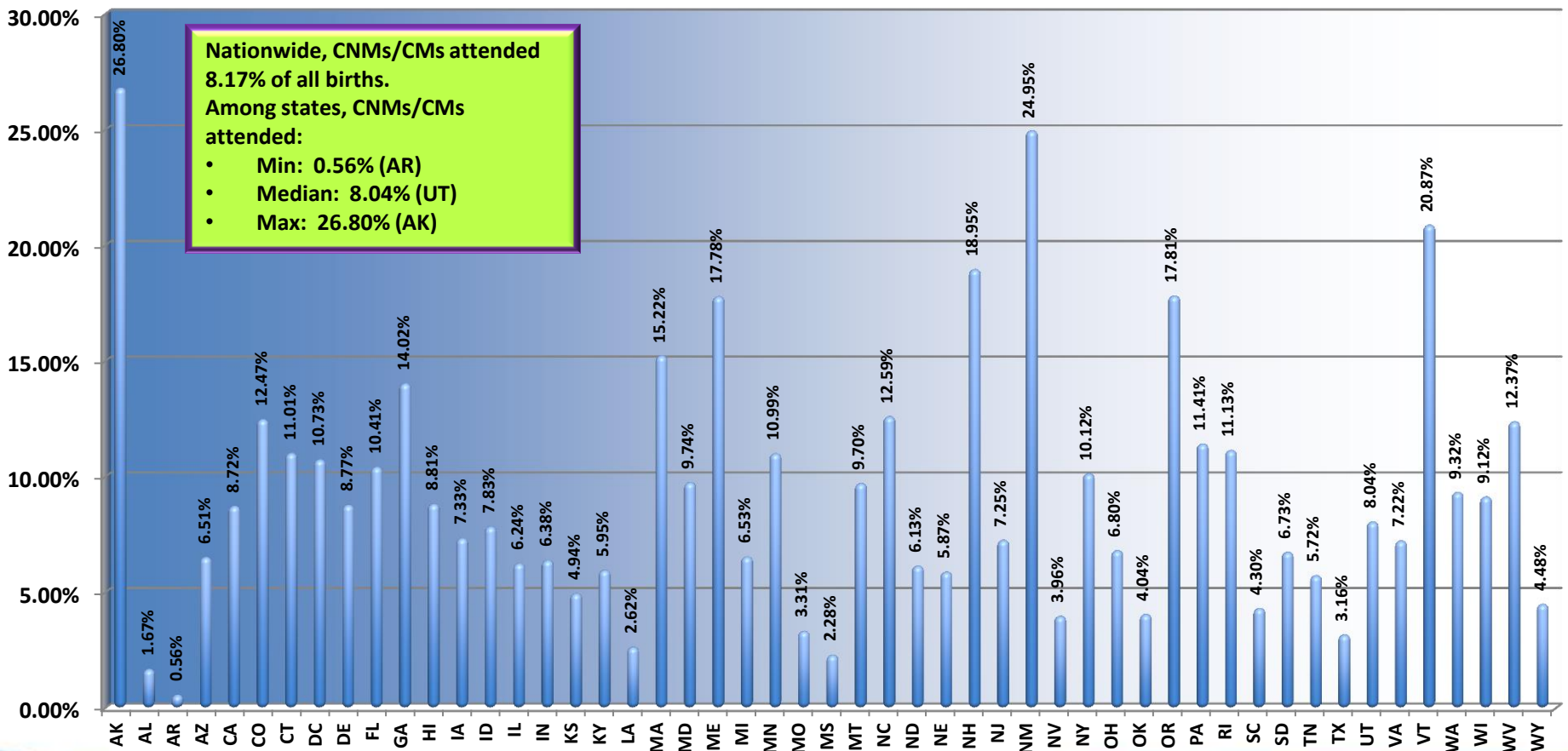

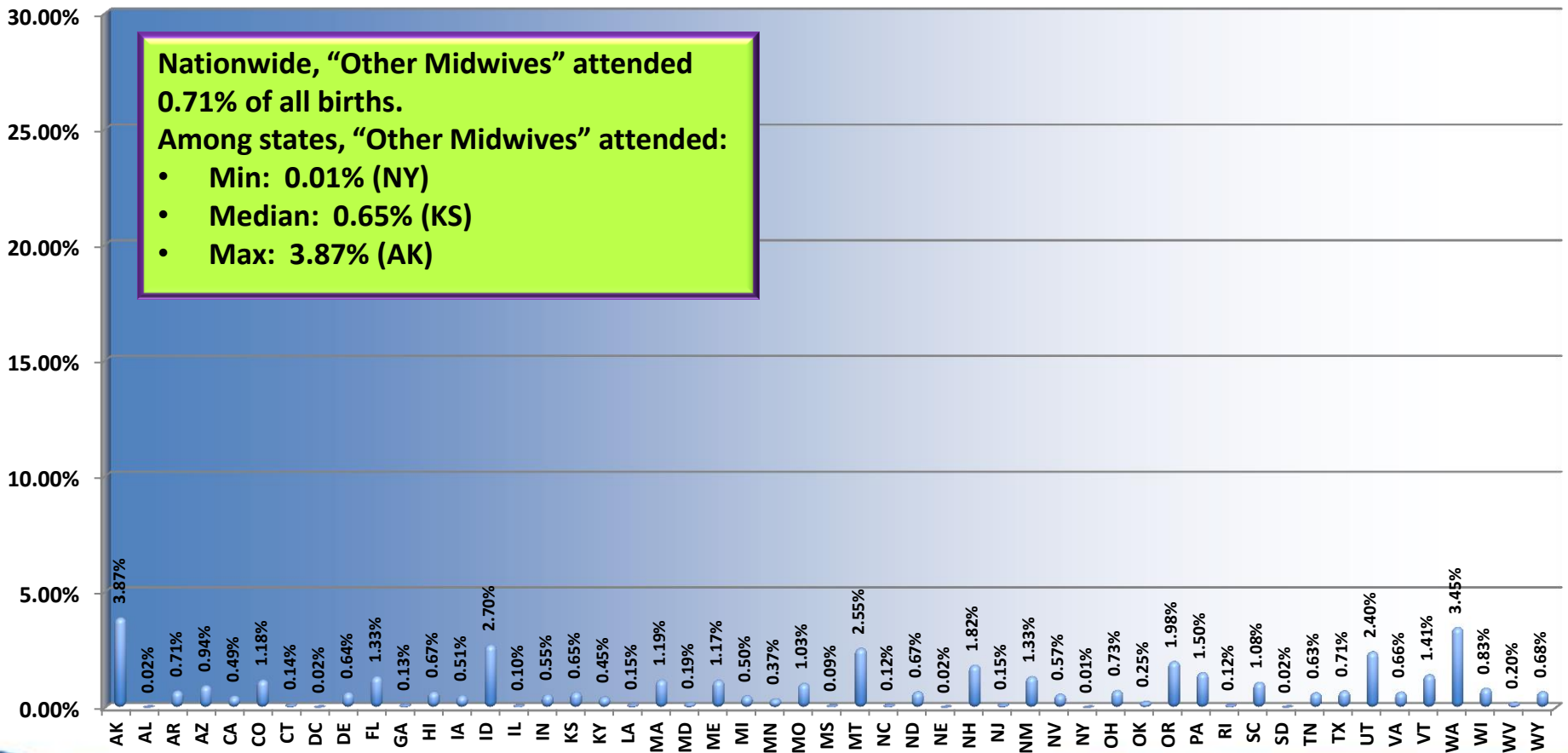
Percent Total Births Attended by CNMs/CMs – 2013

Percent Total Births Attended by “Other Midwives” – 2013



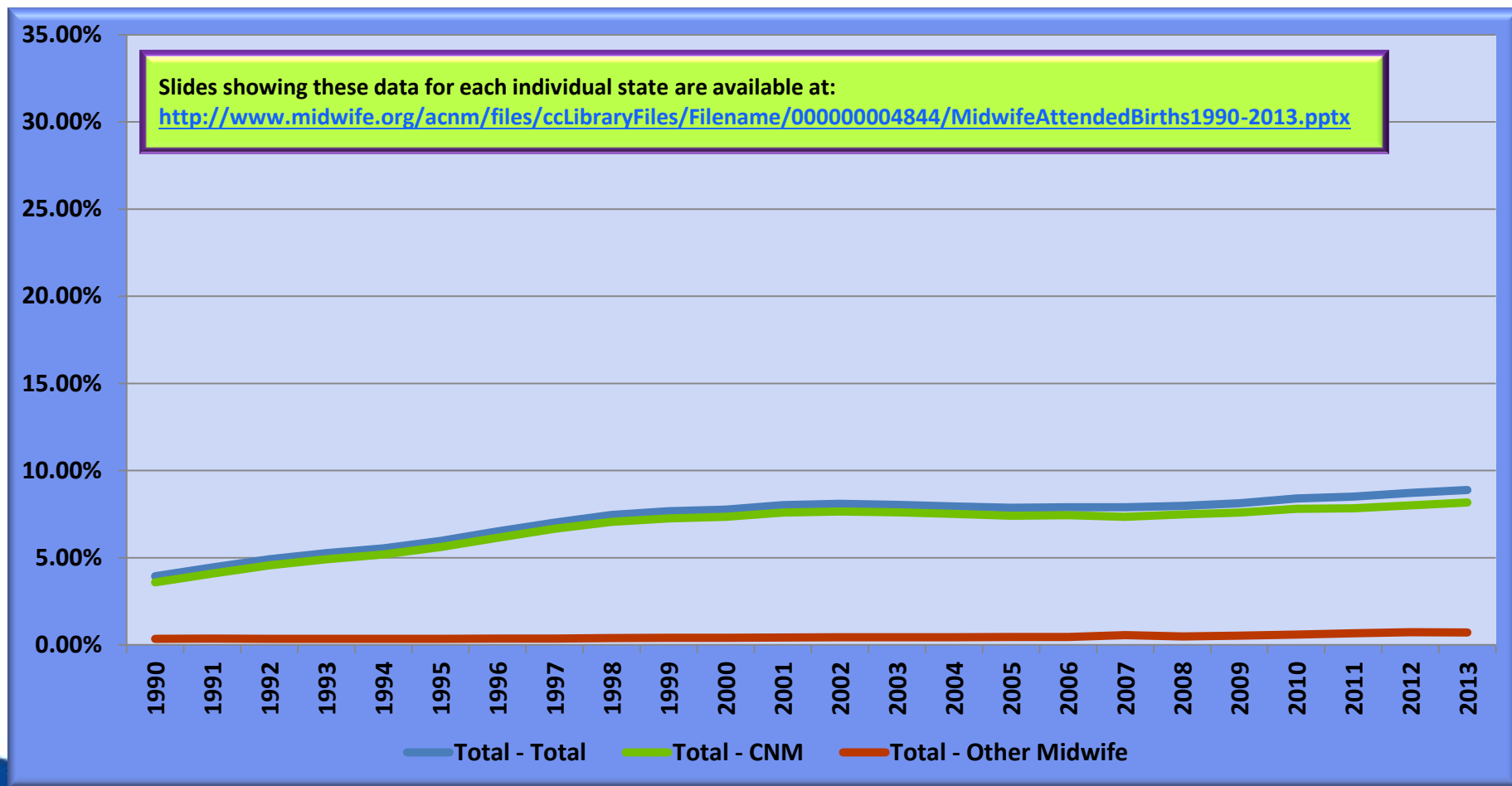

Percent of All US Births Attended by Midwives –1990 - 2013



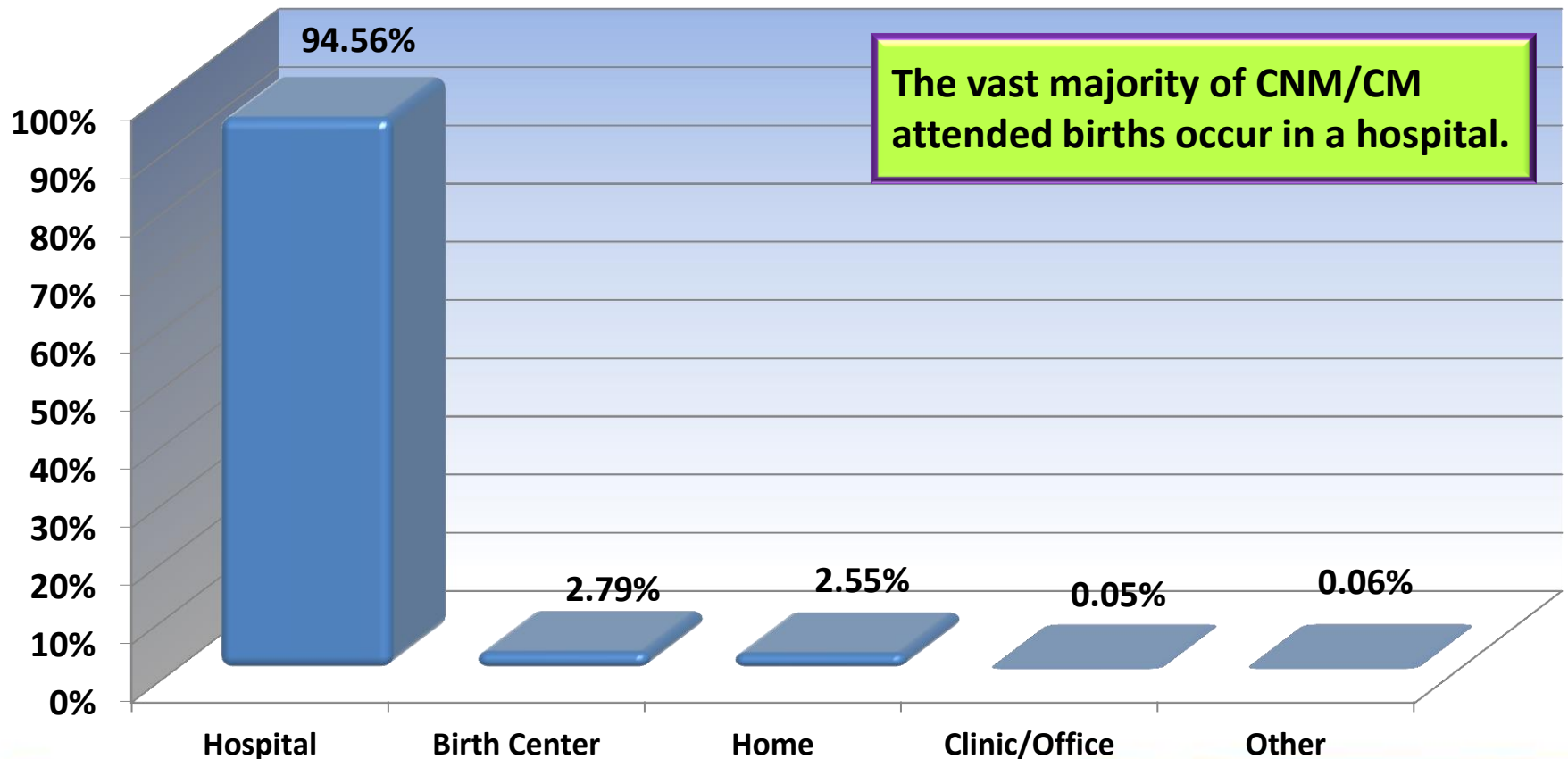

CNM/CM Attended Births by Location - 2013



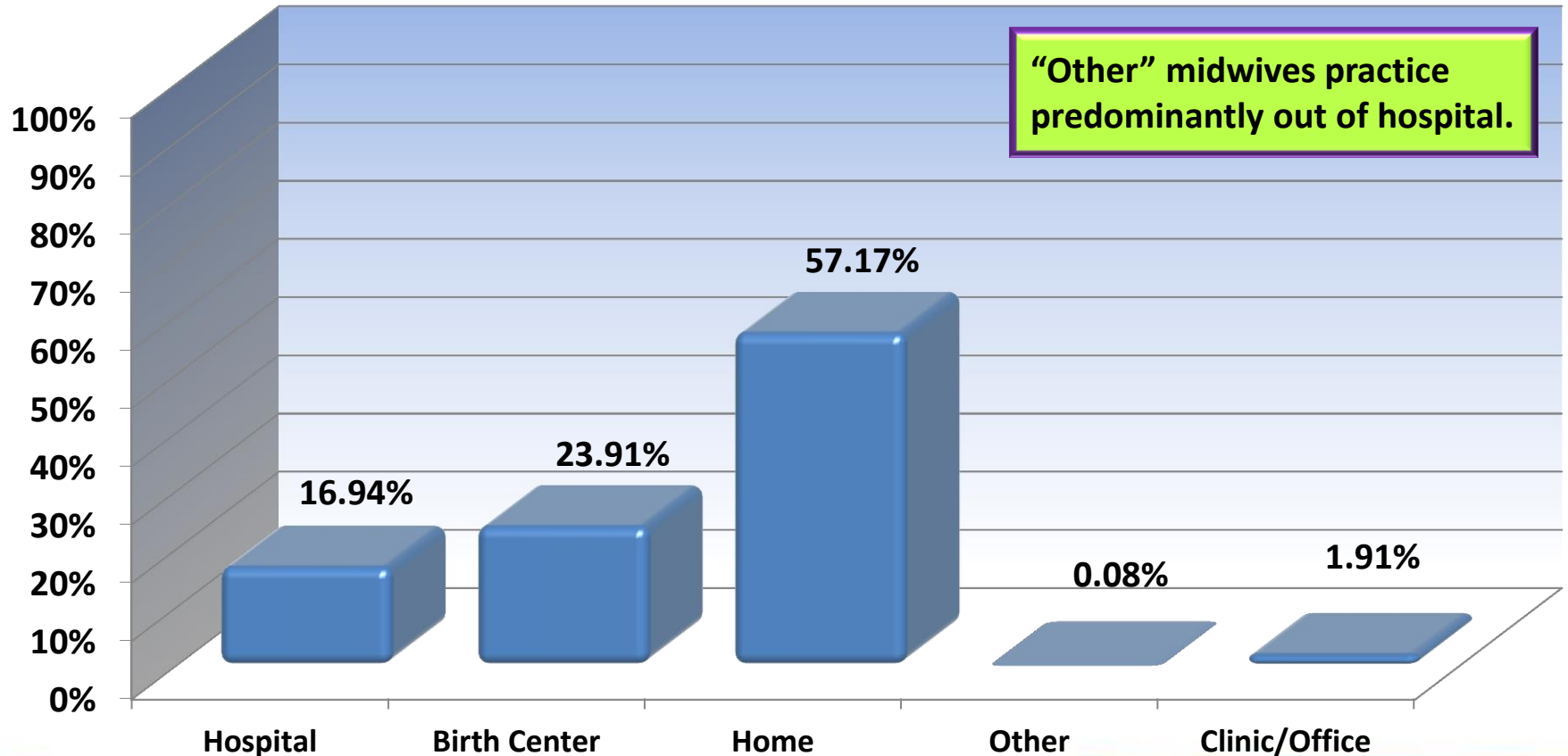

“Other” Midwife Attended Births by Location - 2013



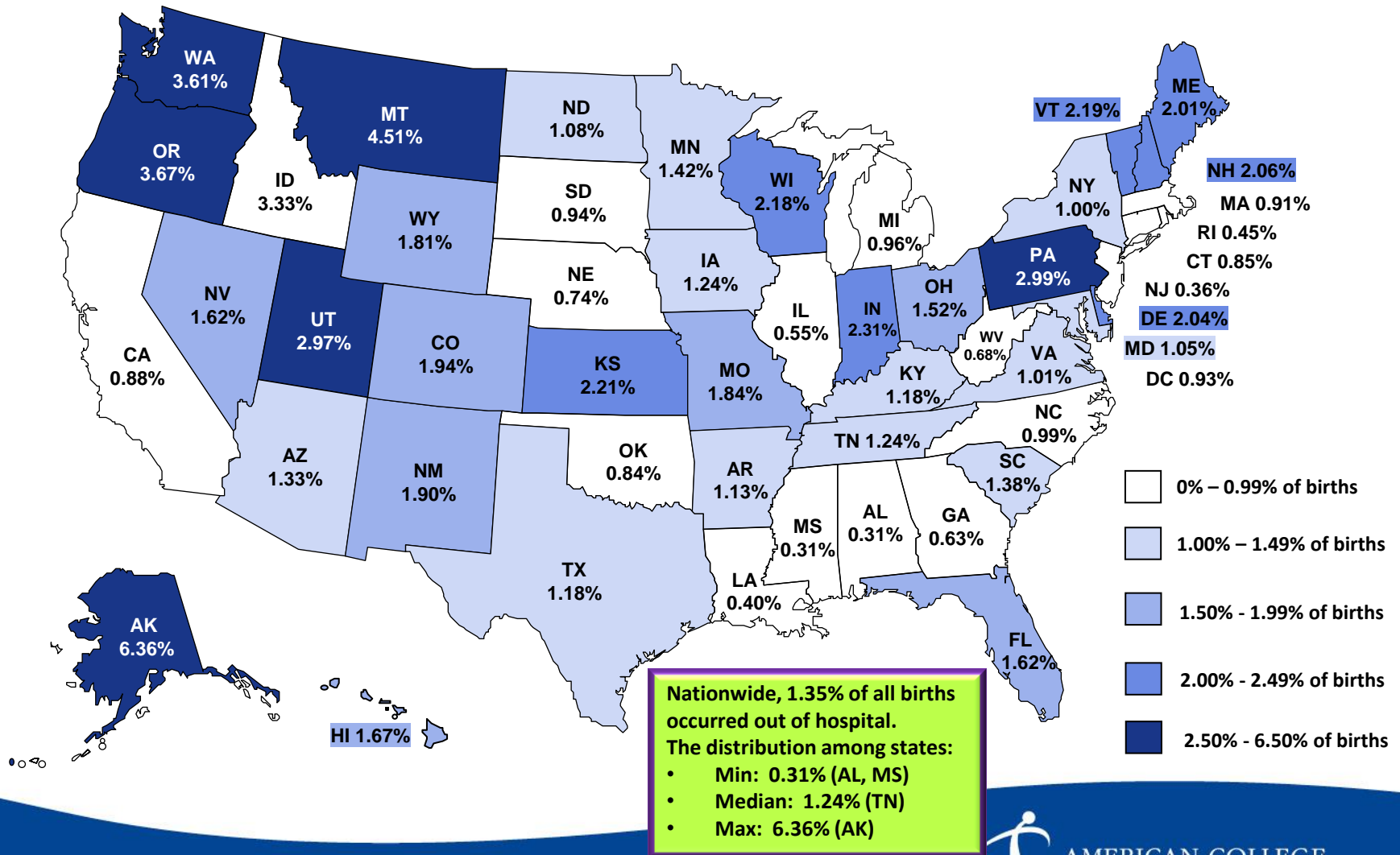

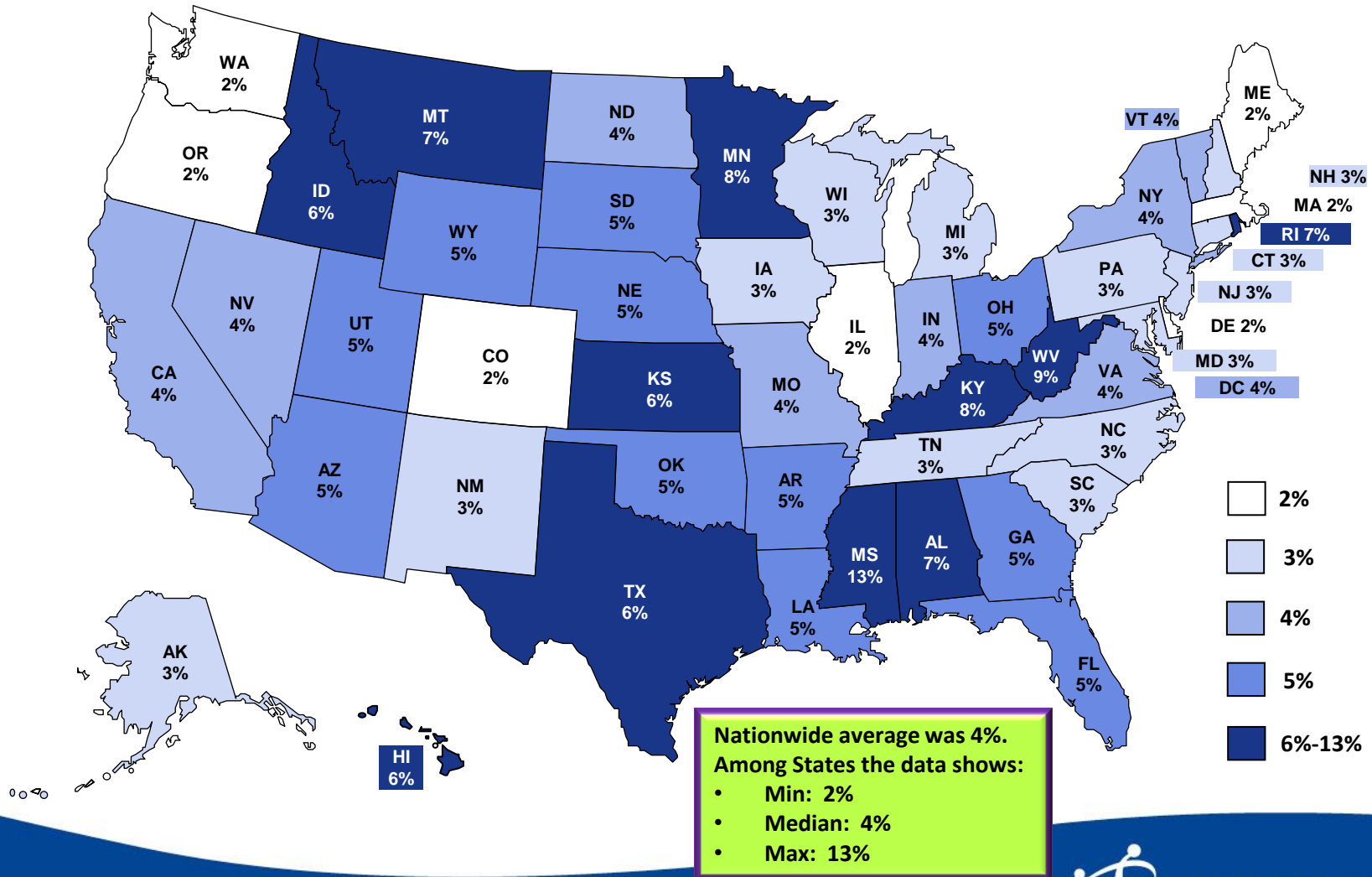

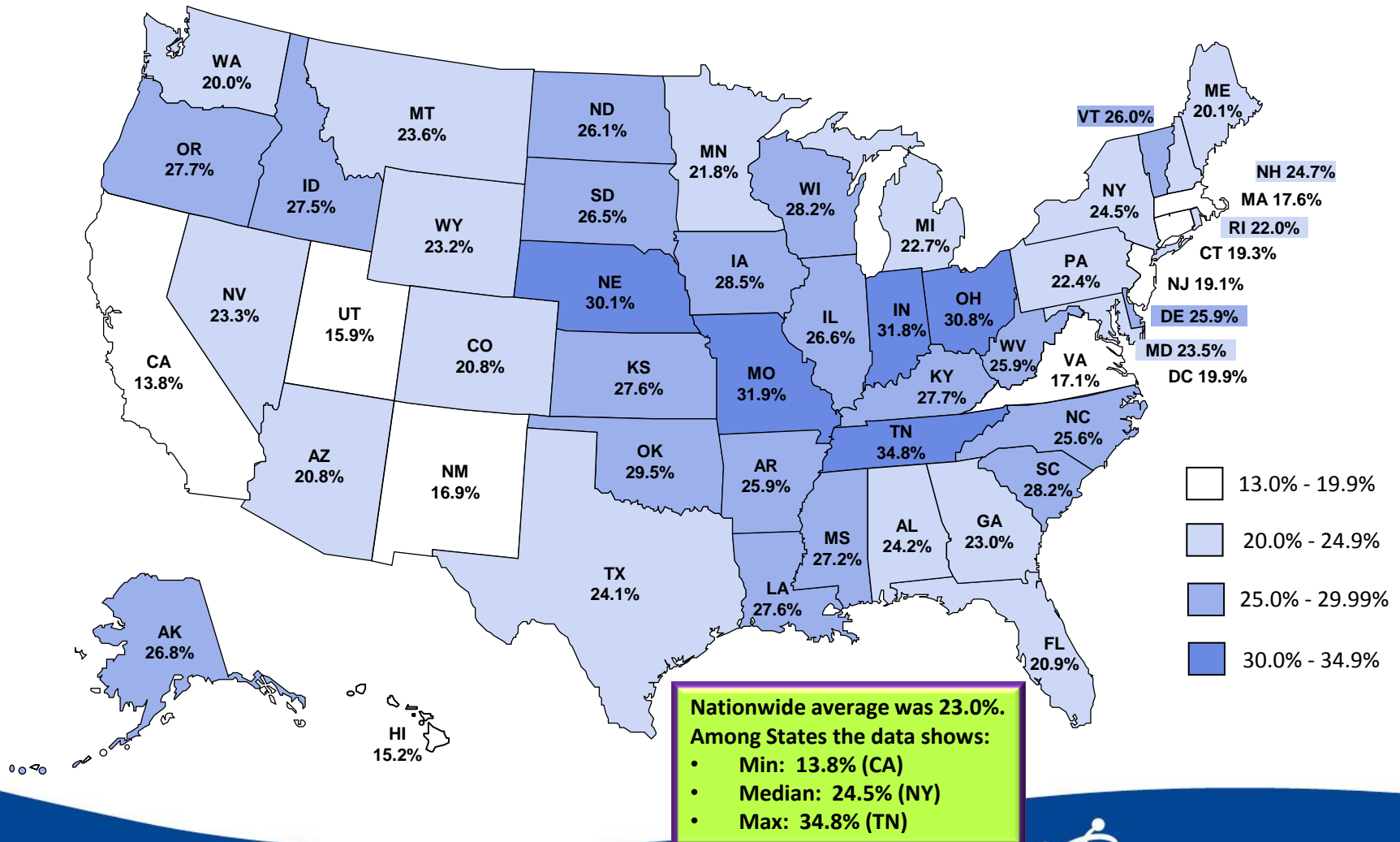

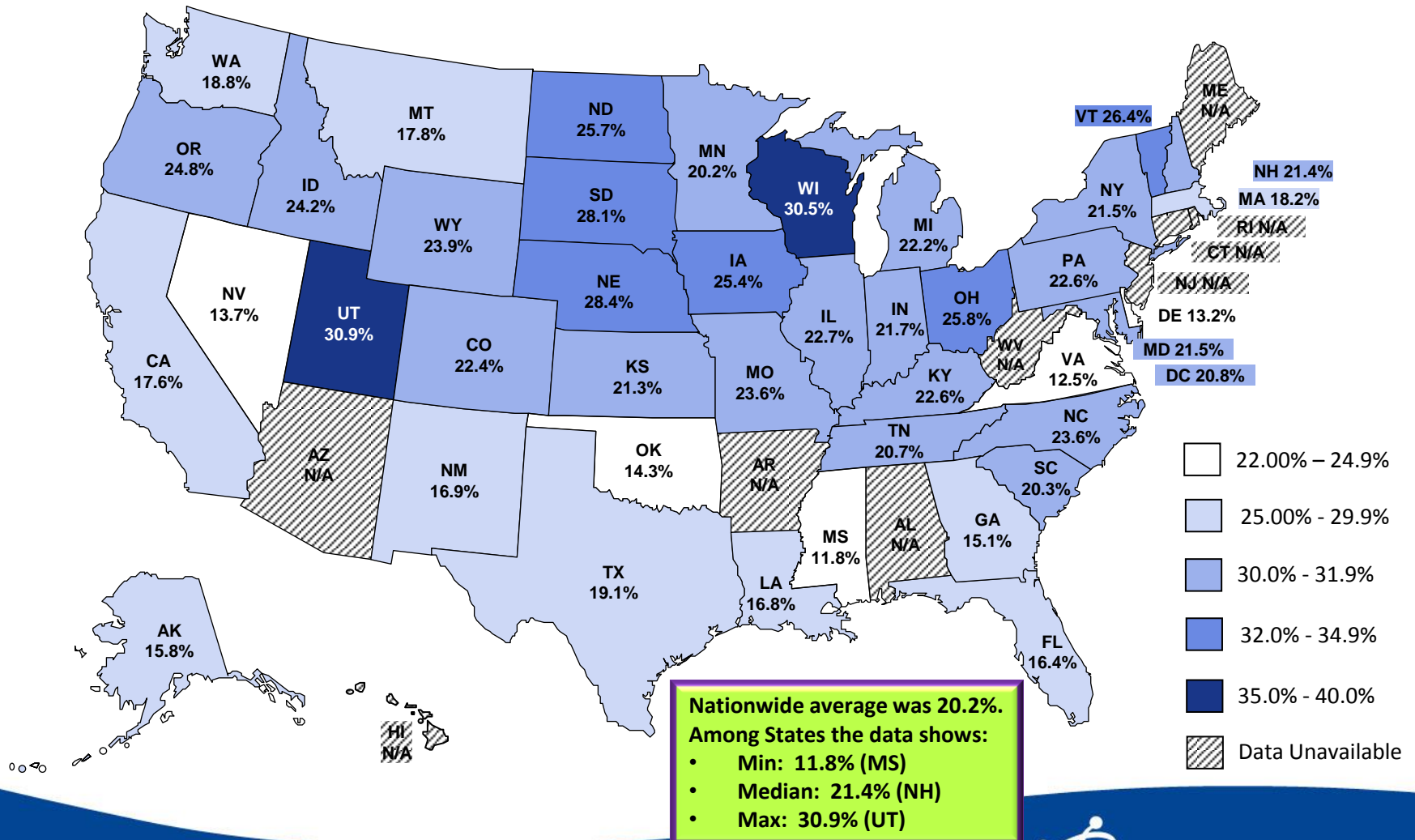


Total Rate of Induction - 2013



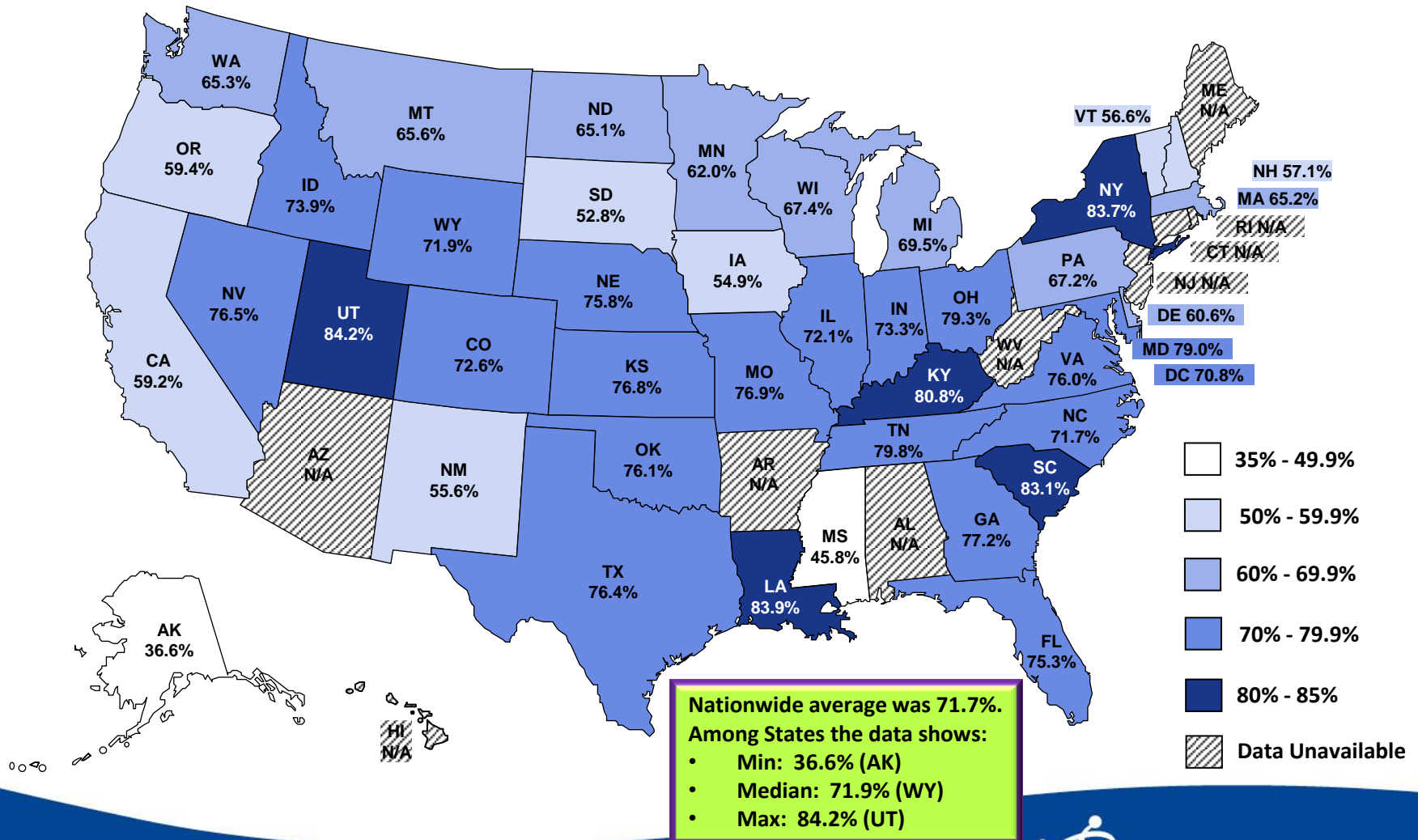

Total Rate of Augmentation - 2013



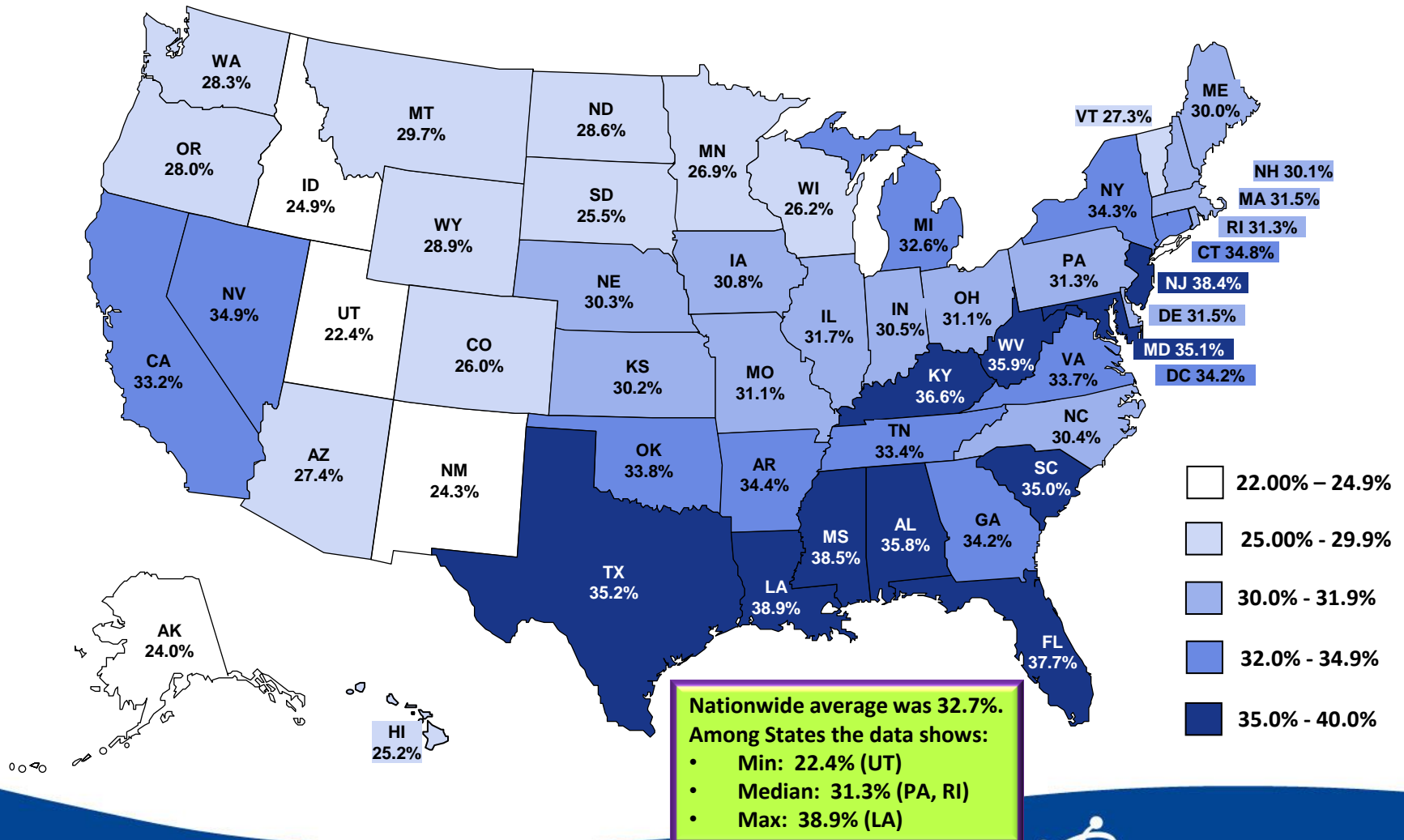

Total Rate of Epidural - 2013



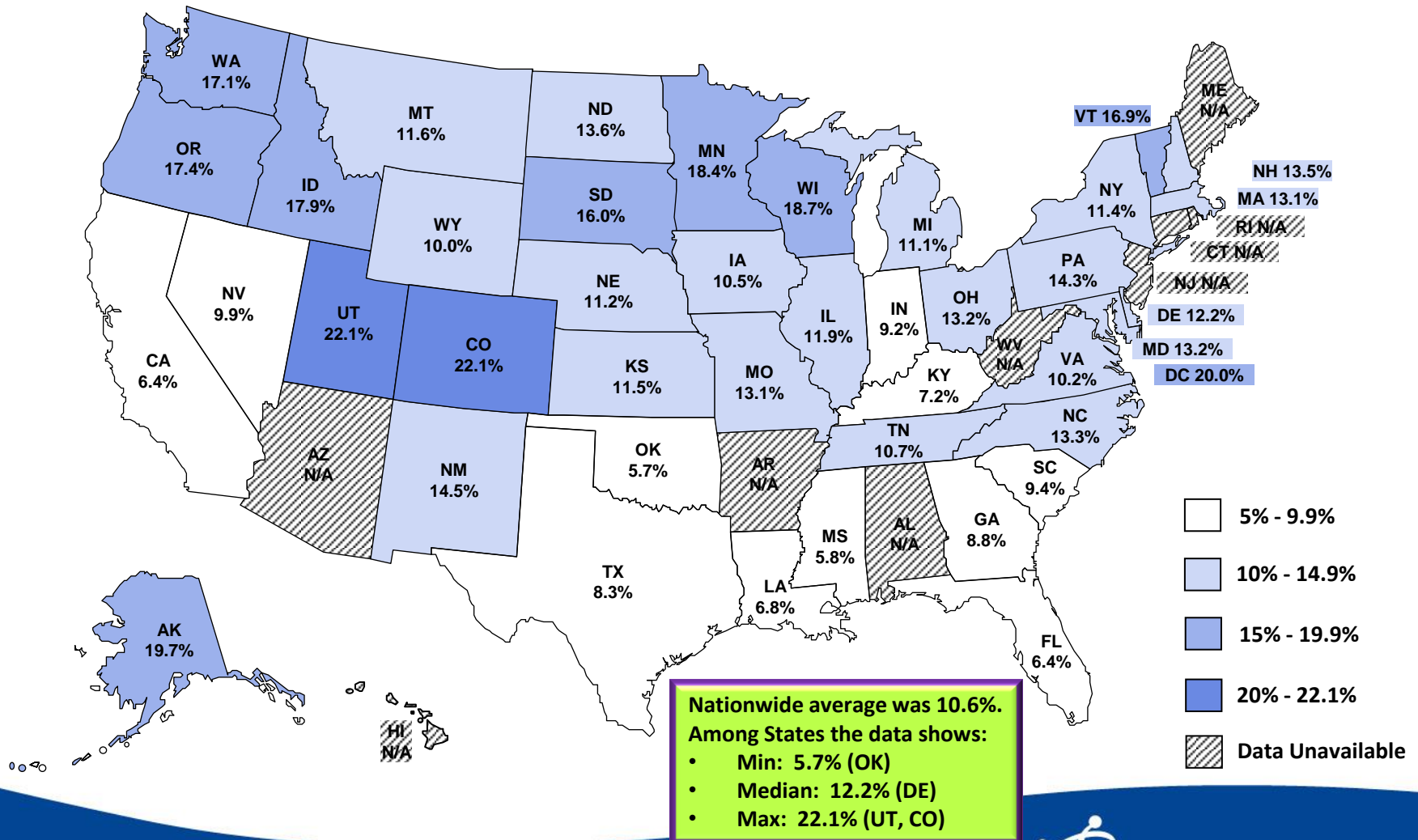

Total Rate of Cesarean Birth - 2013



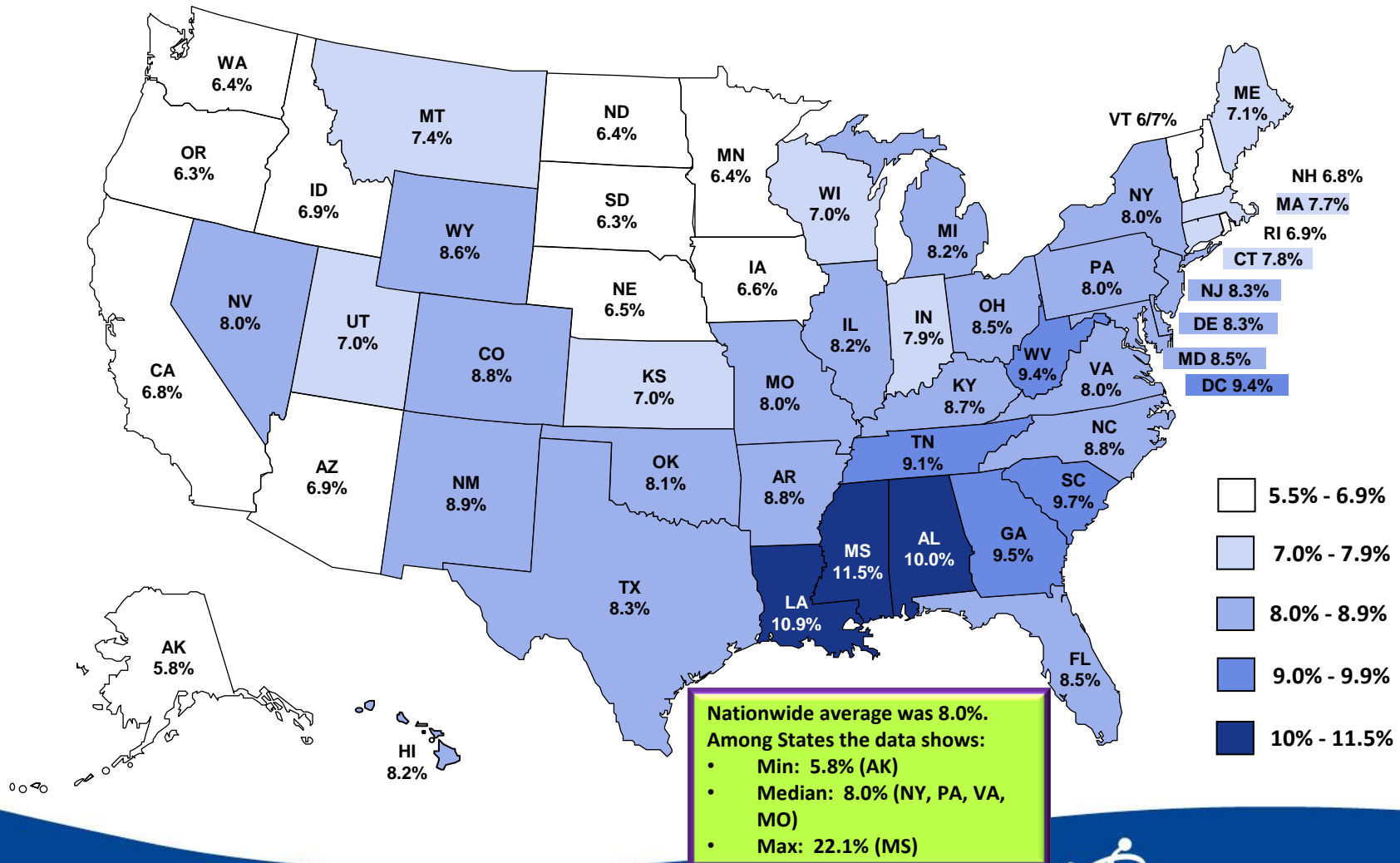

Percent of Women with Prior Cesarean who Gave Birth Vaginally - 2013



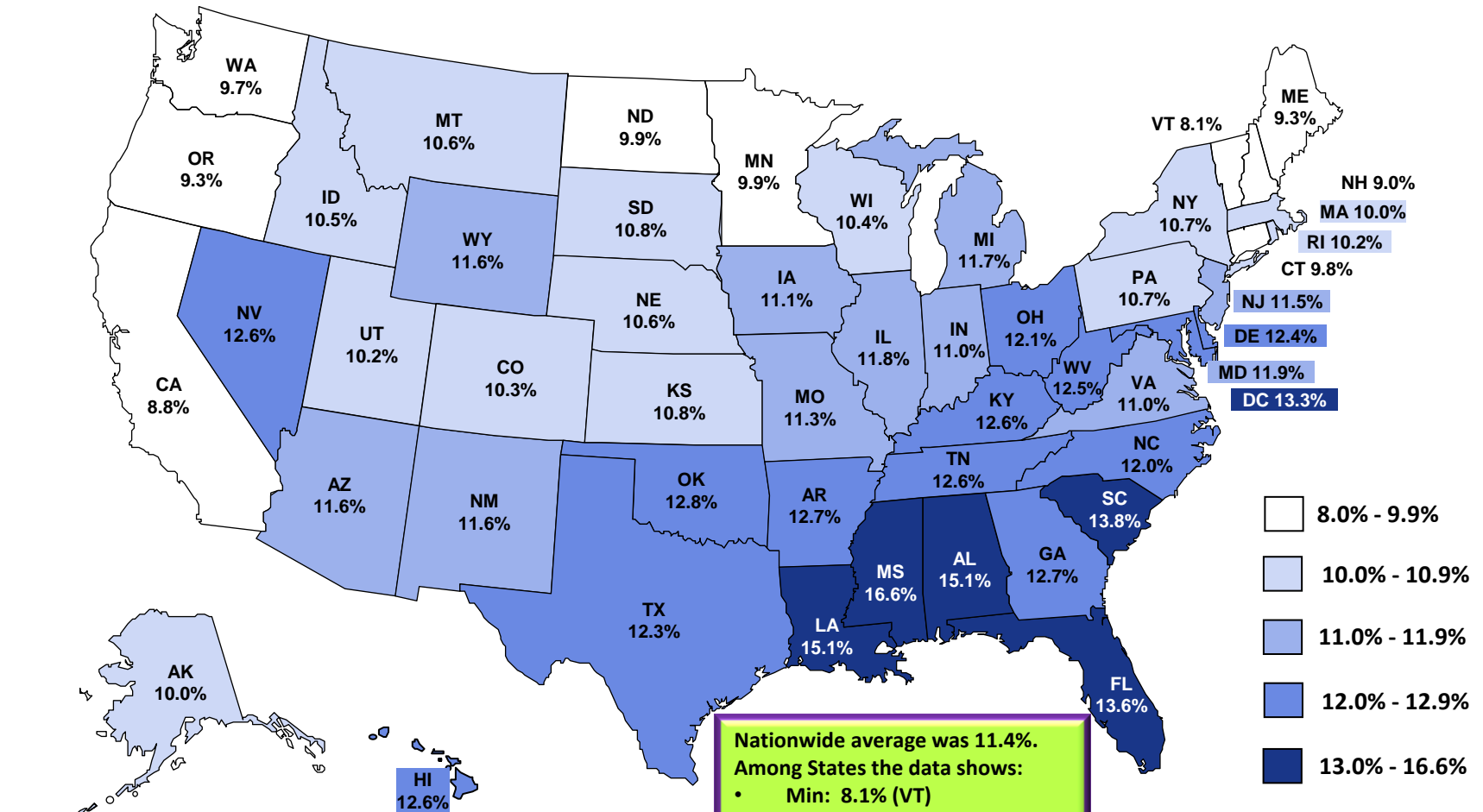

Total Rate of Low Birth Weight - 2013



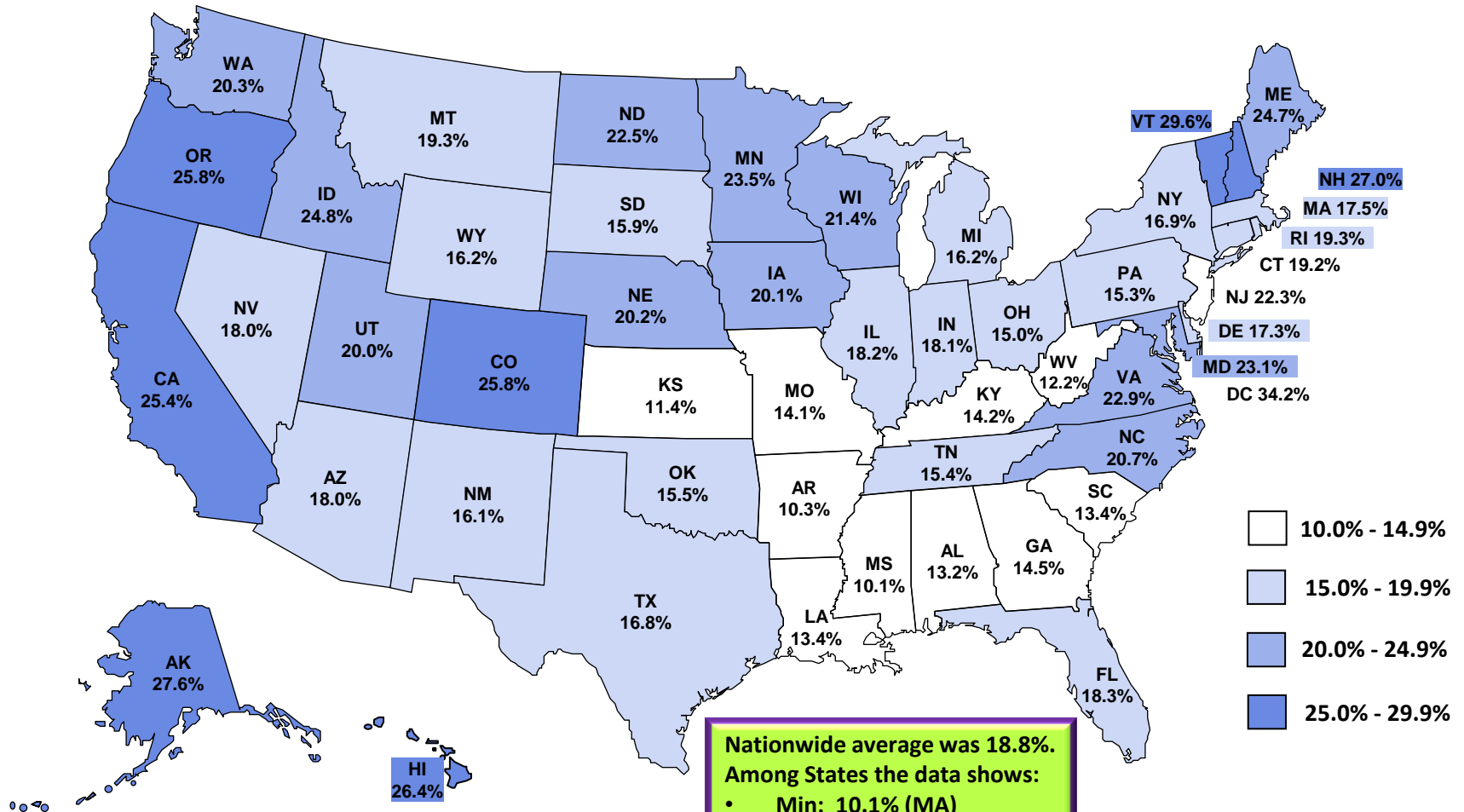

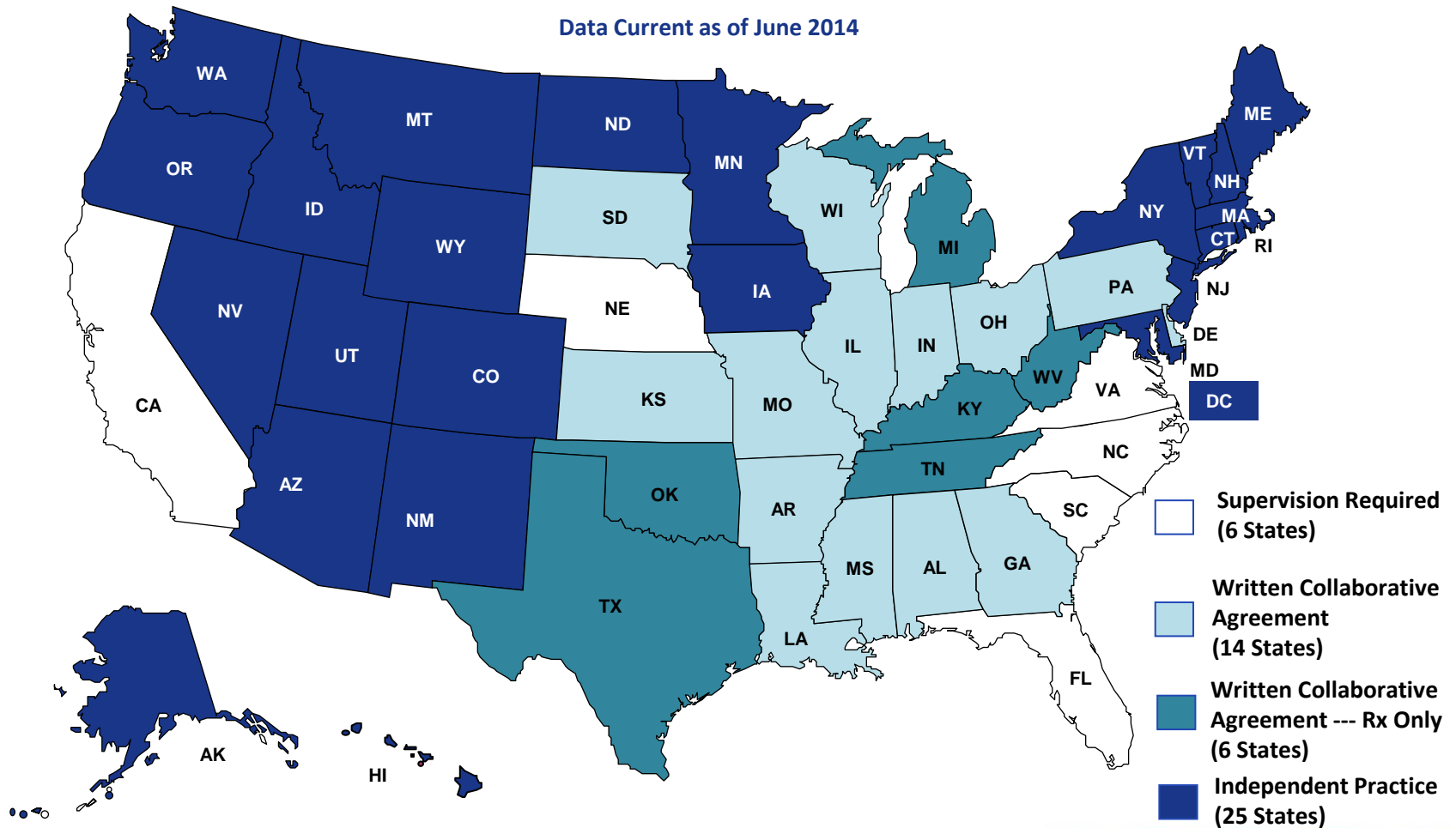

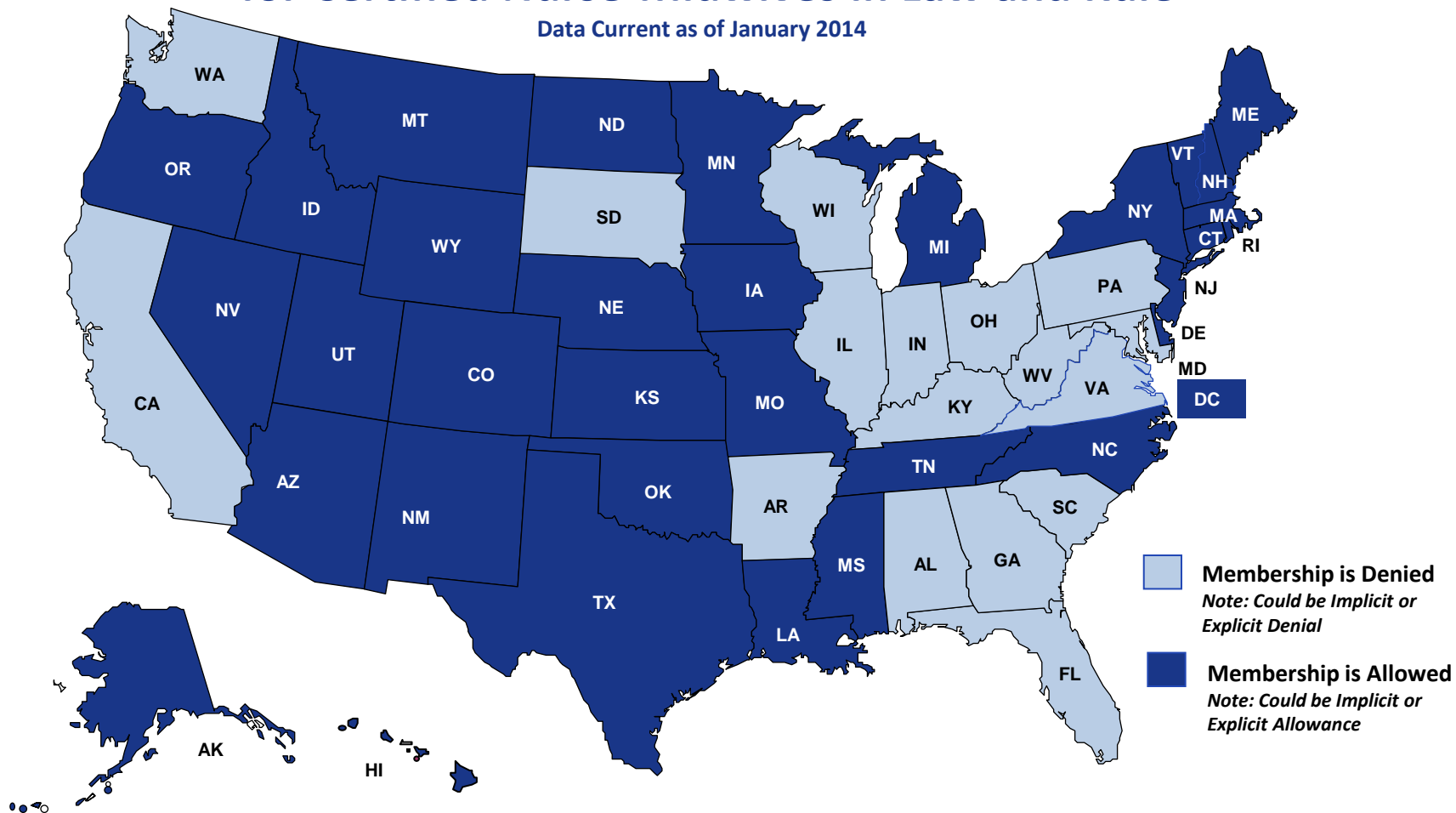
Regulatory Structure for Certified Nurse-Midwives and Certified Midwives

Data Current as of June 2014



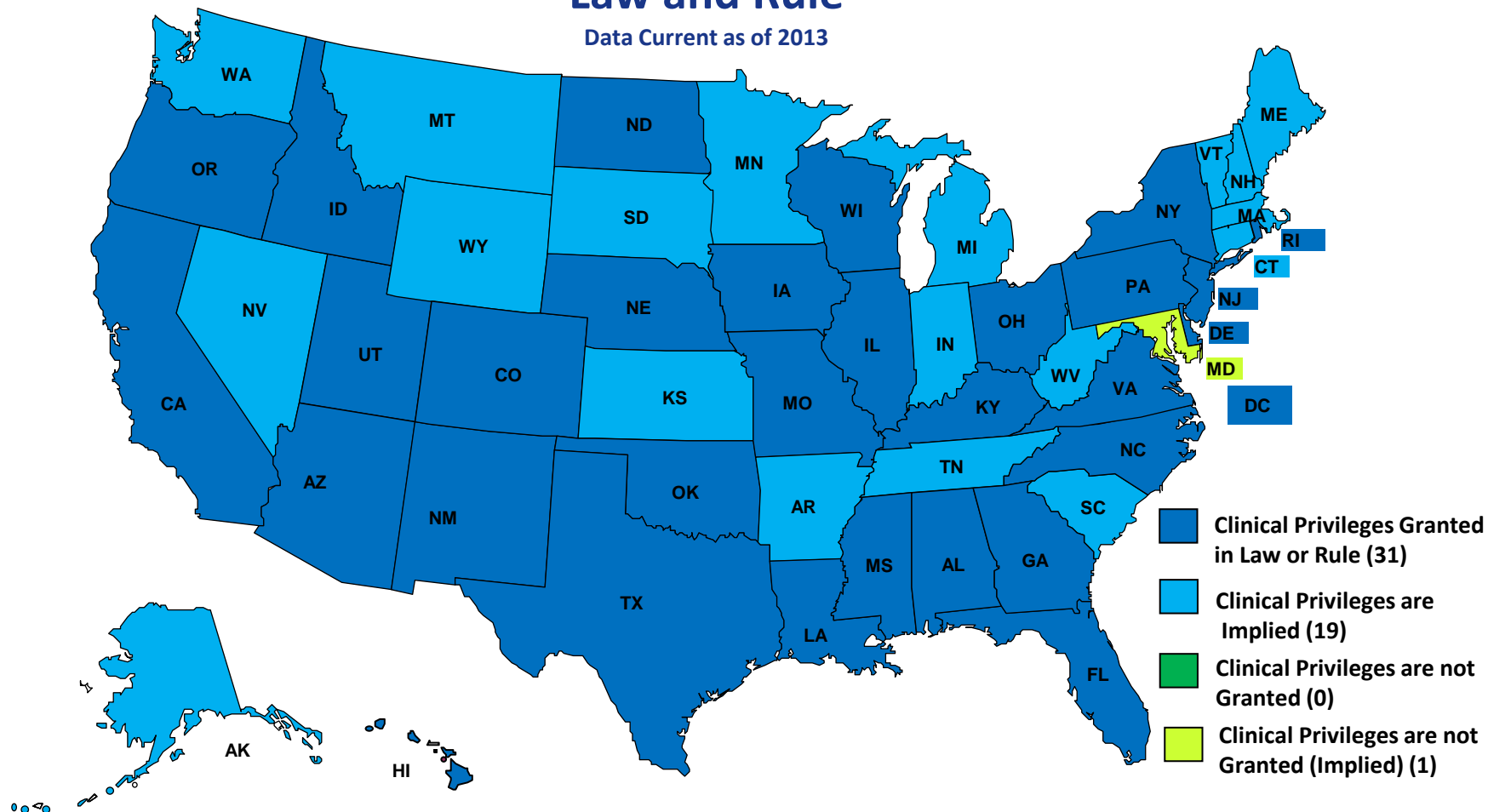
Medical Staff Provisions

Data Current as of January 2014



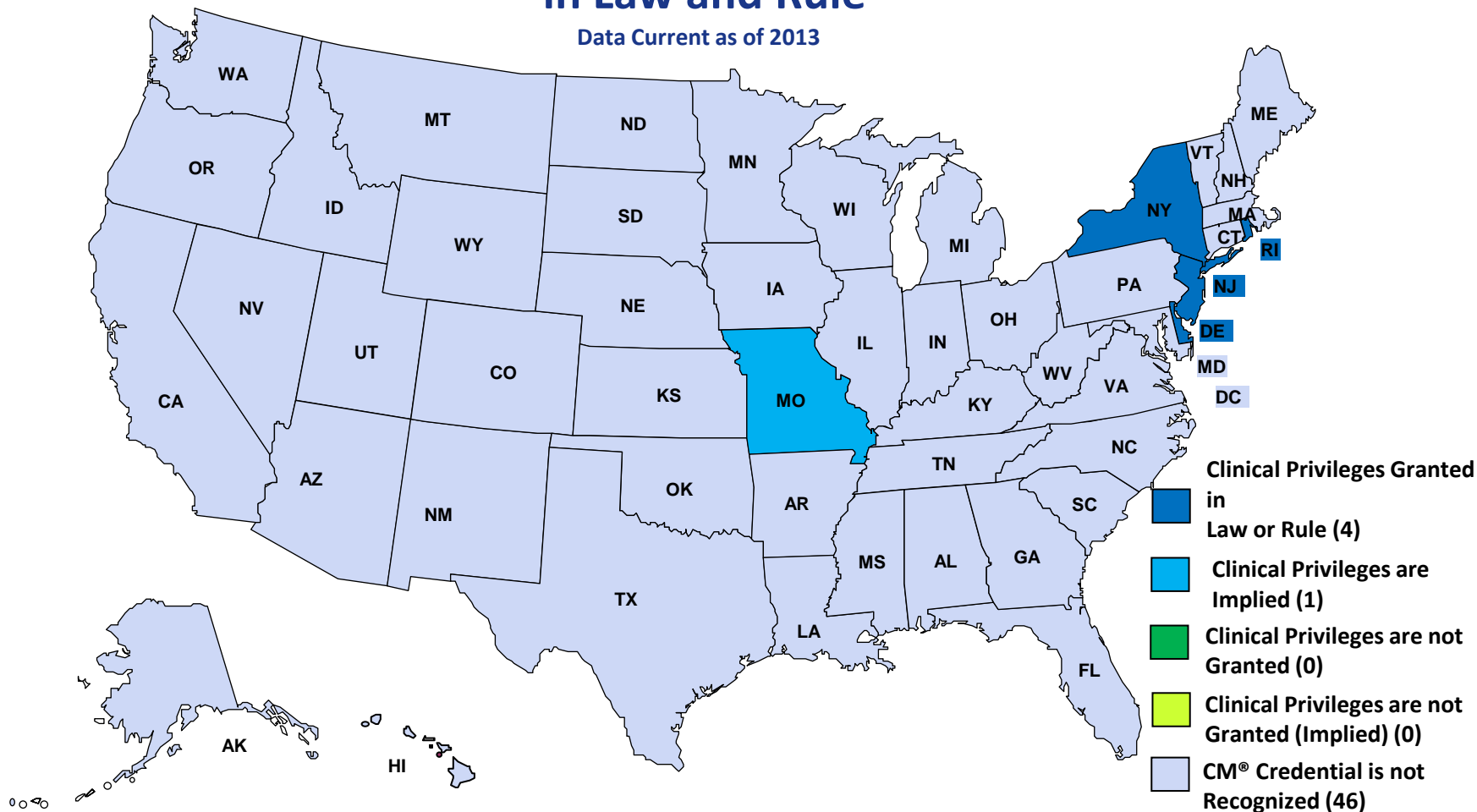
Clinical Privileging Provisions for Certified Nurse-Midwives (CNM®) in Law and Rule

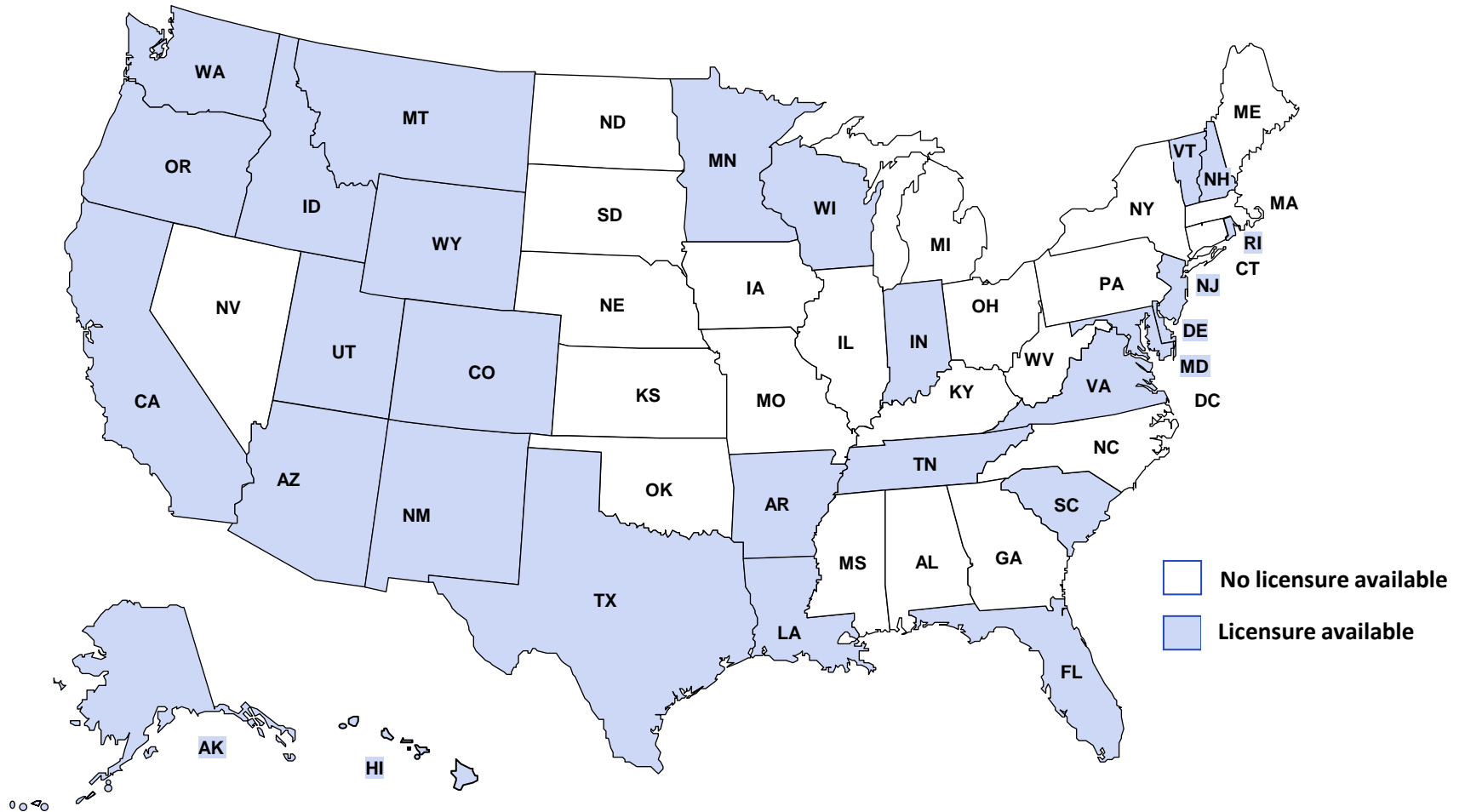

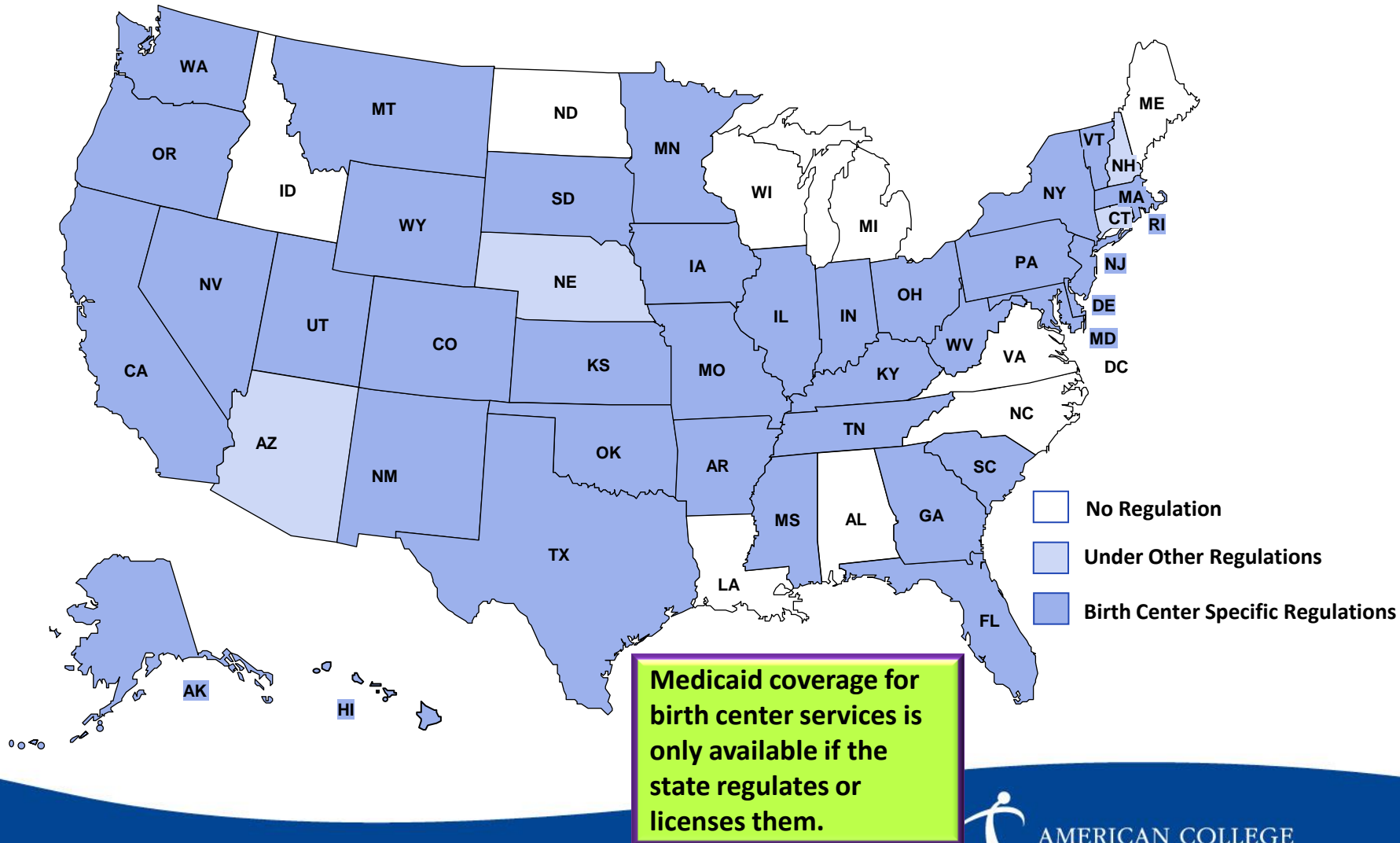


States that License Direct Entry Midwives

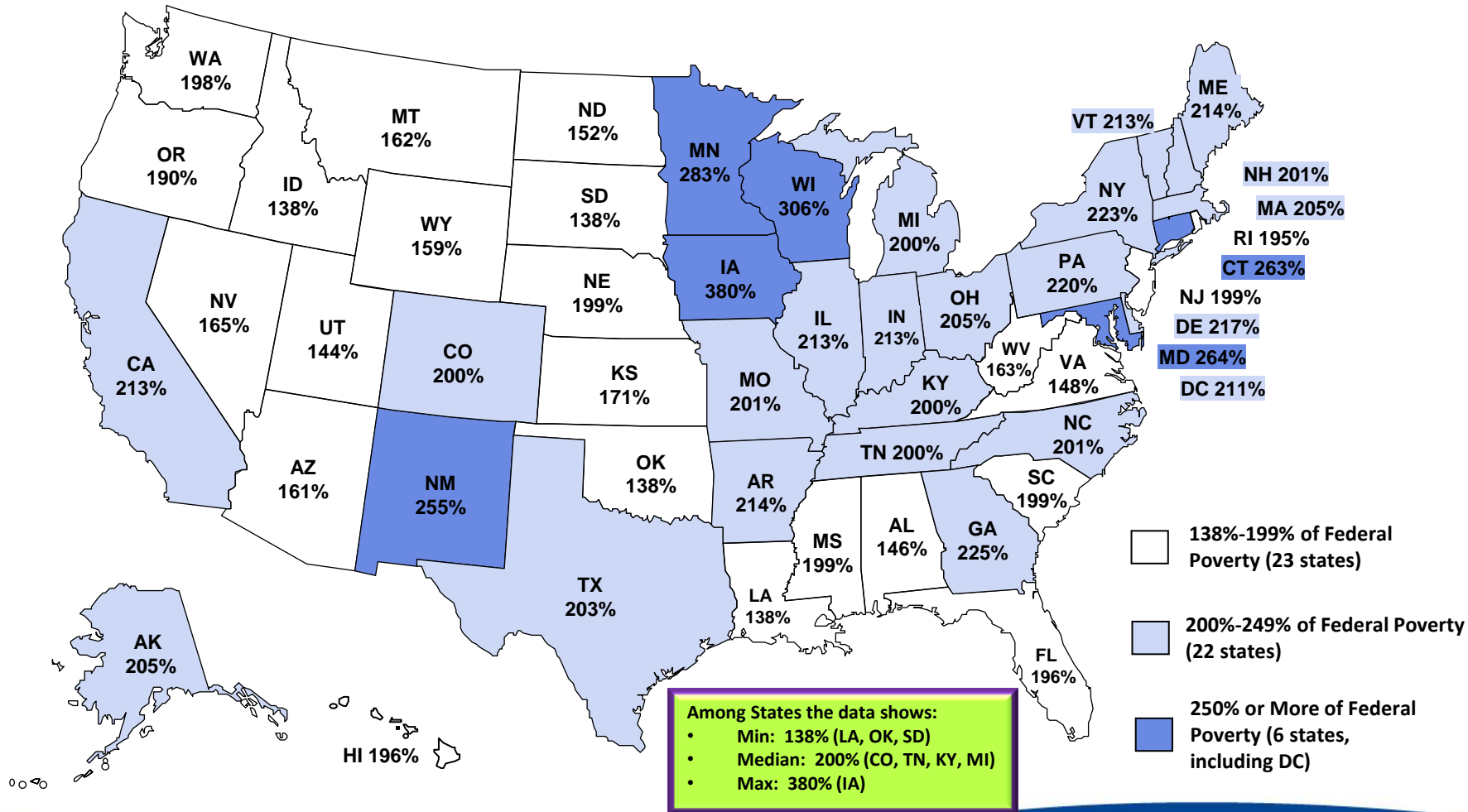

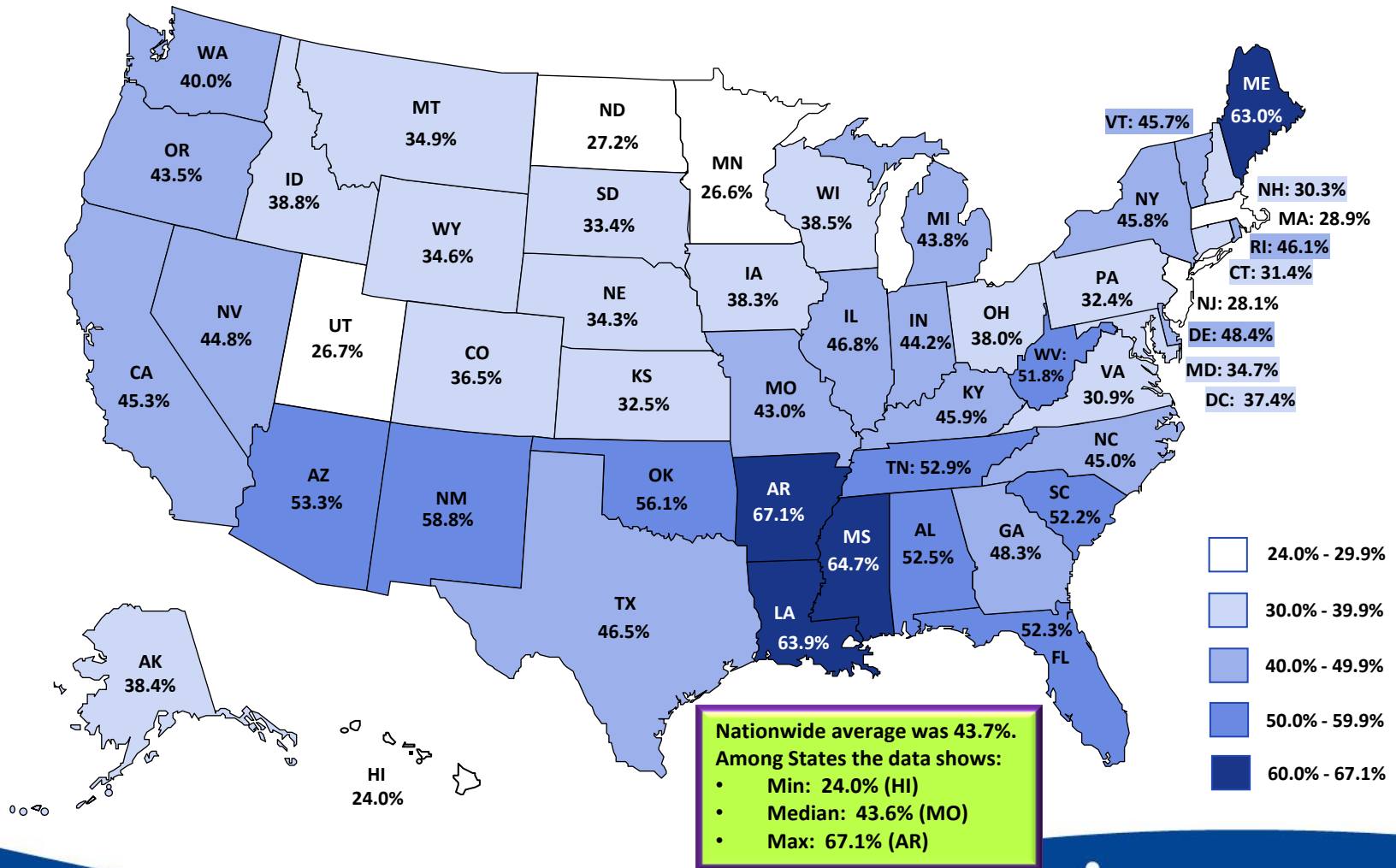

Income Eligibility Levels for Pregnant Women to Obtain Medicaid Coverage

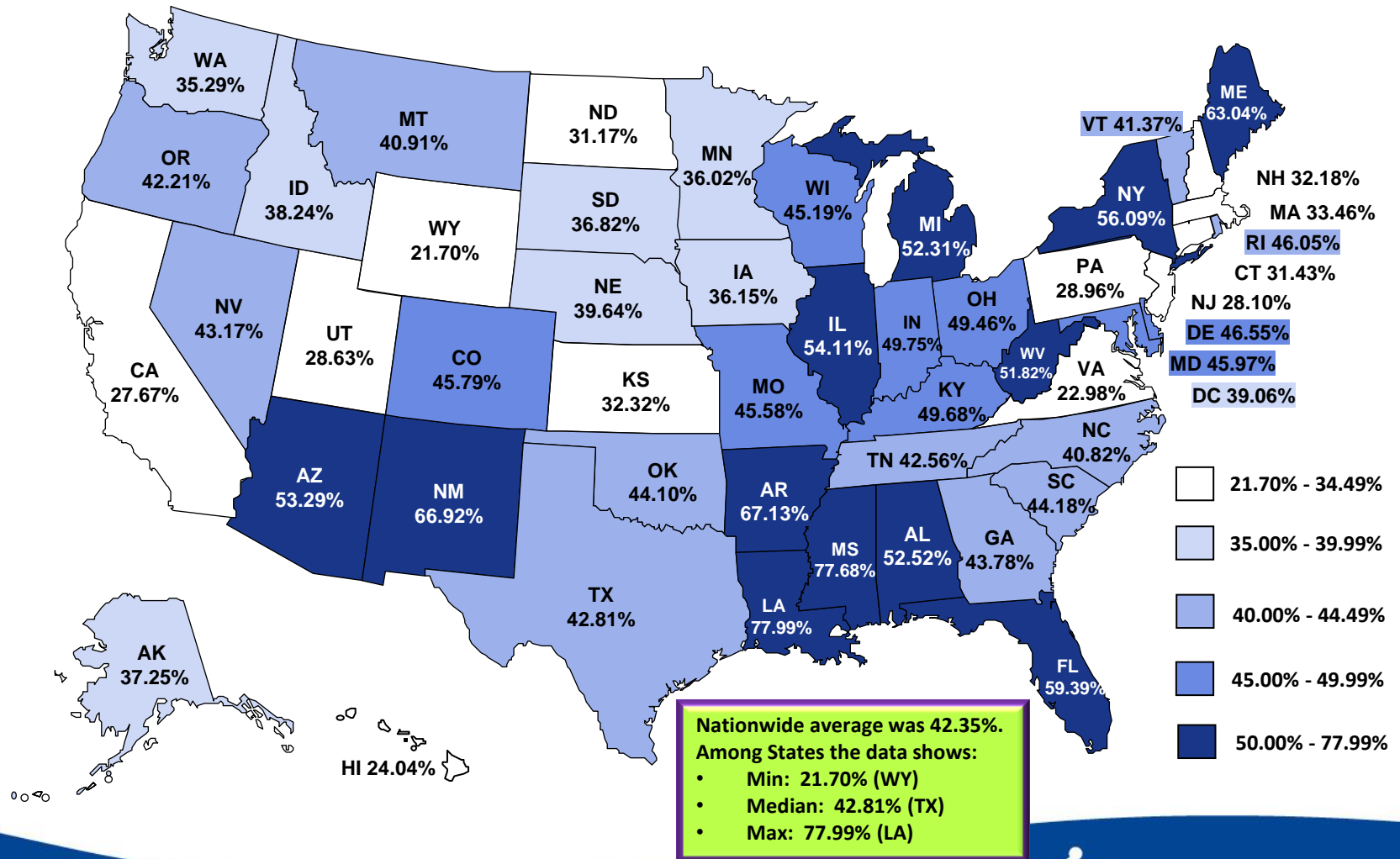
As a Percent of the Federal Poverty Level, Data Current as of January 1, 2015



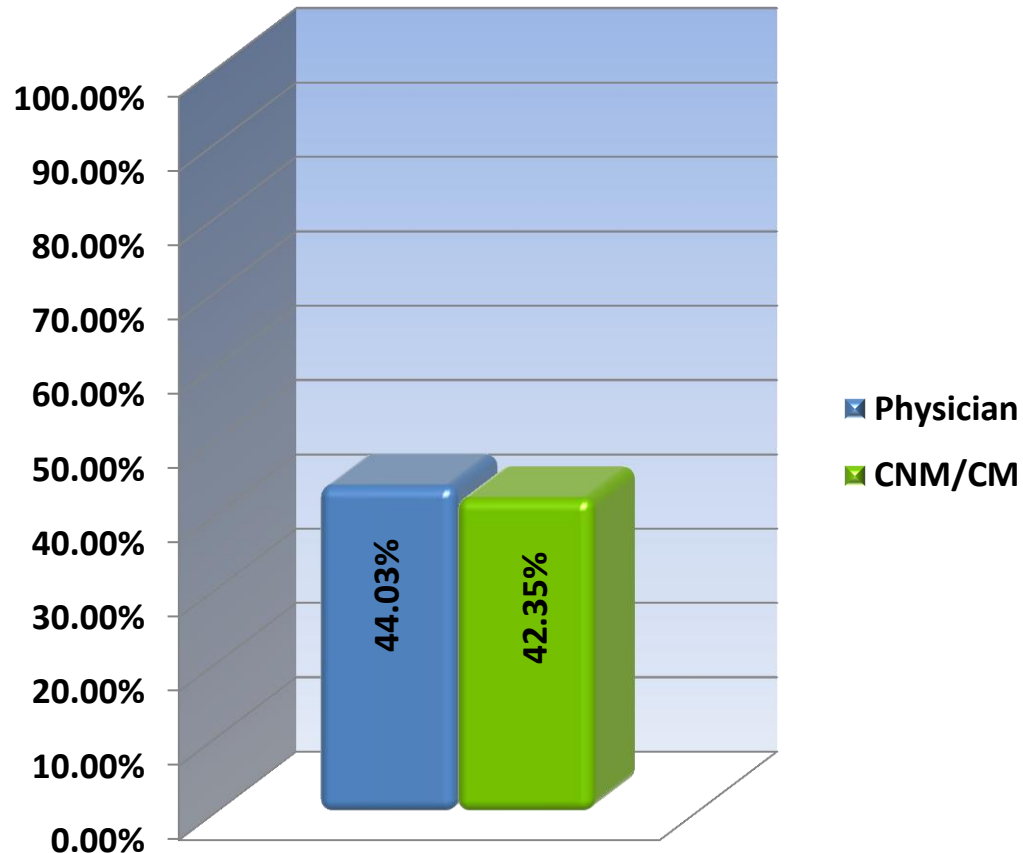
Percentage of Births Covered by Medicaid – 2013*

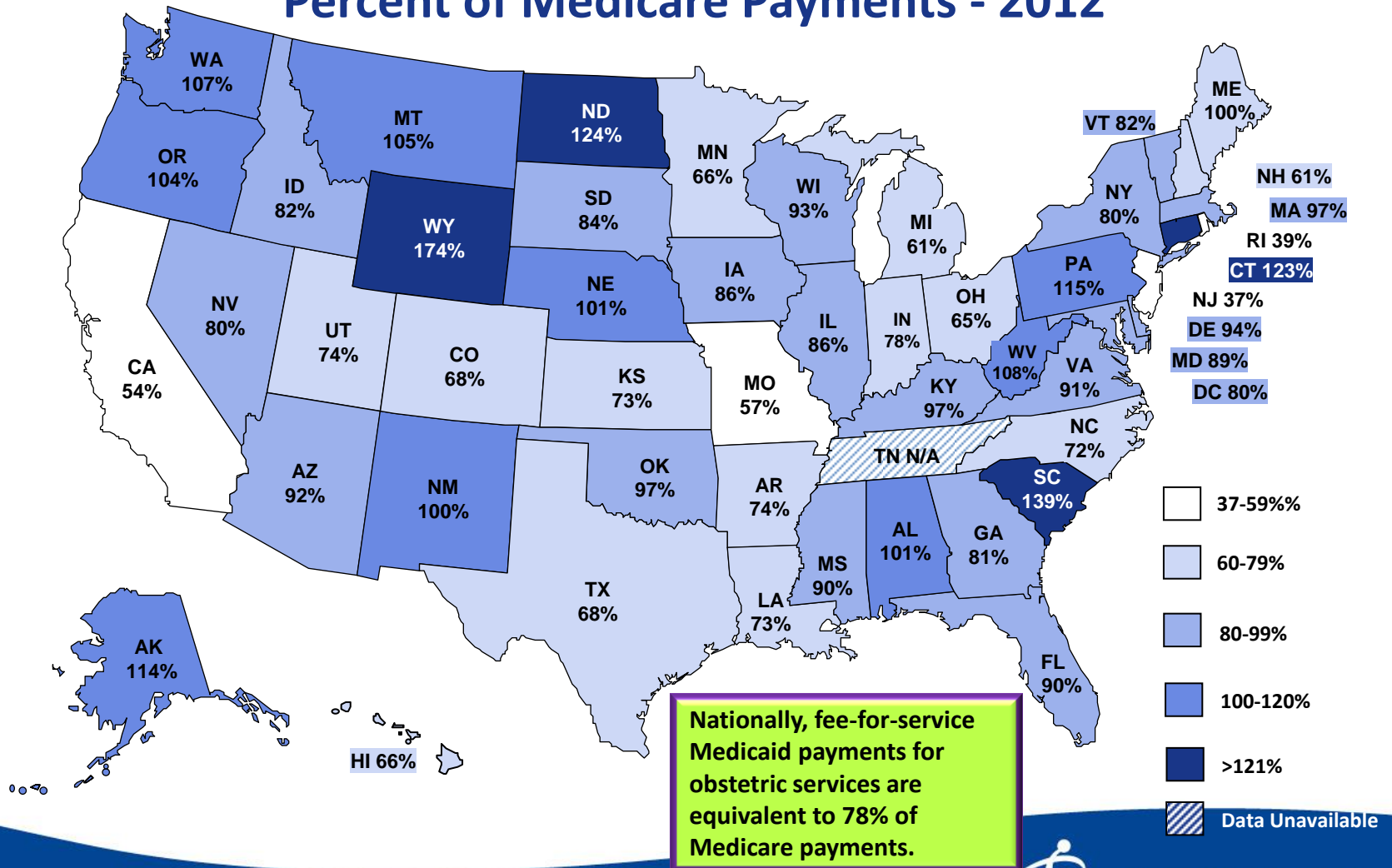

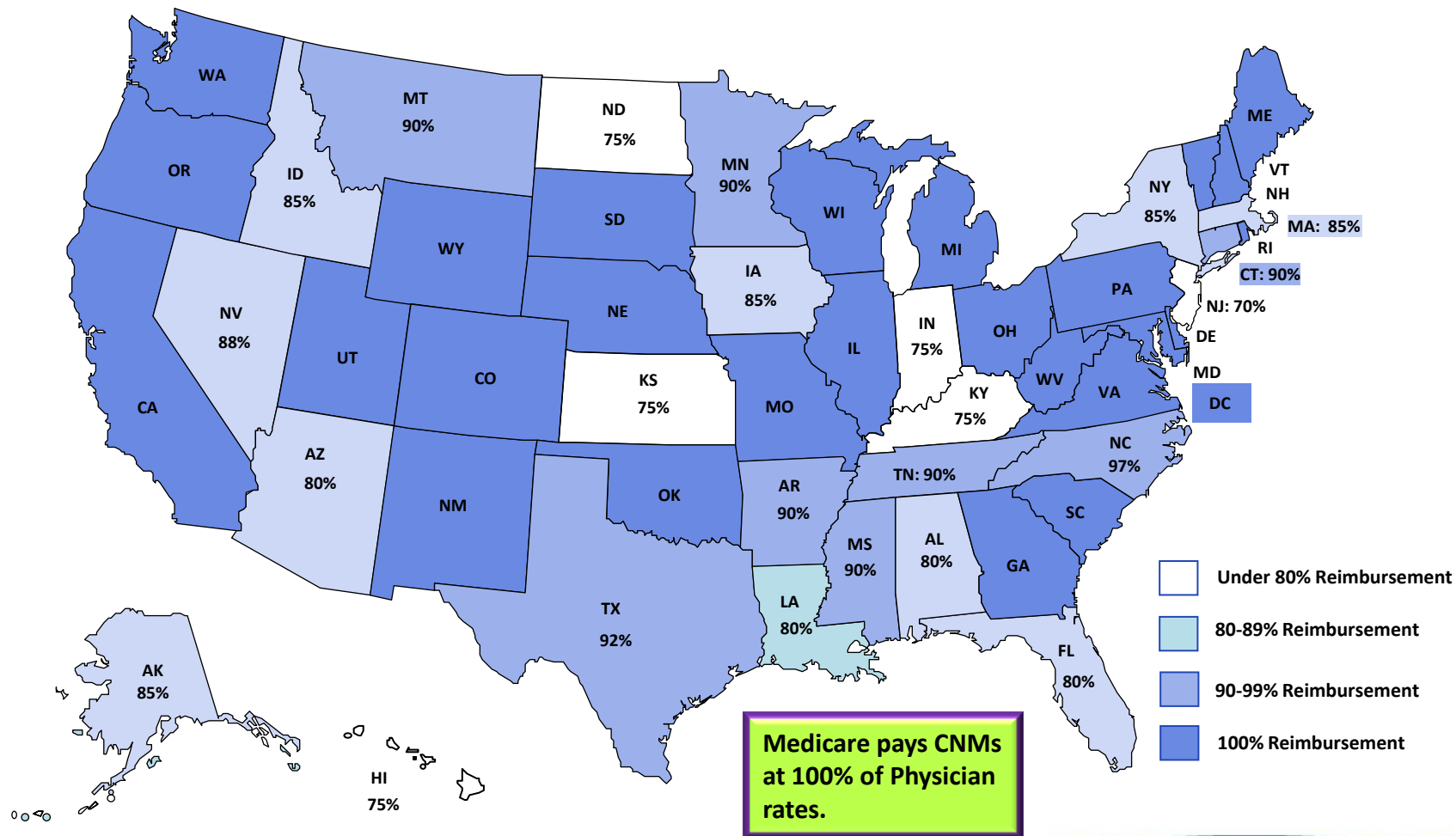

Medicaid Fee-for-Service Payments for Obstetric Services as a Percent of Medicare Payments - 2012

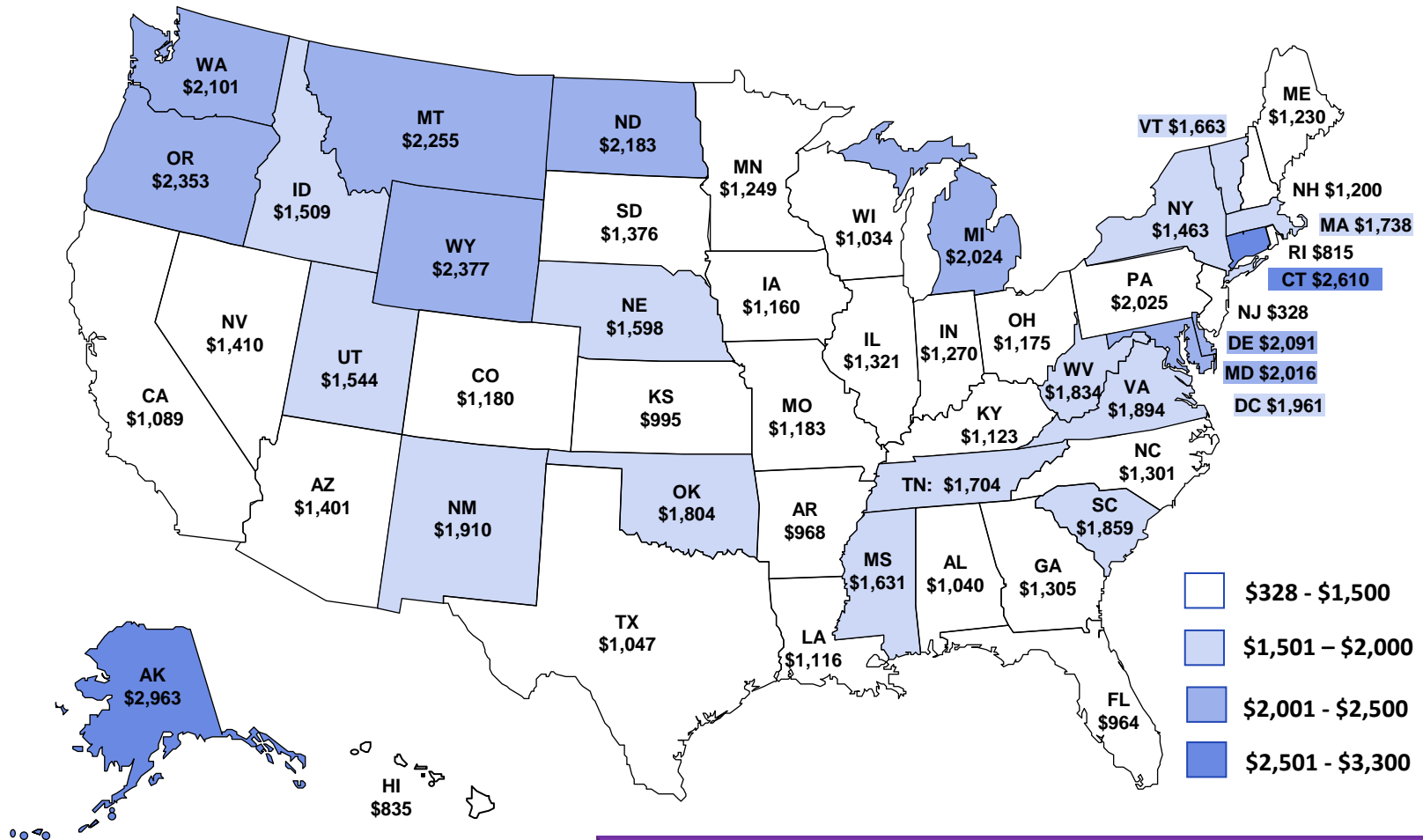


Medicaid Fee-for-Service Payments to CNMs/CMs as a Percent of Payment to Physicians

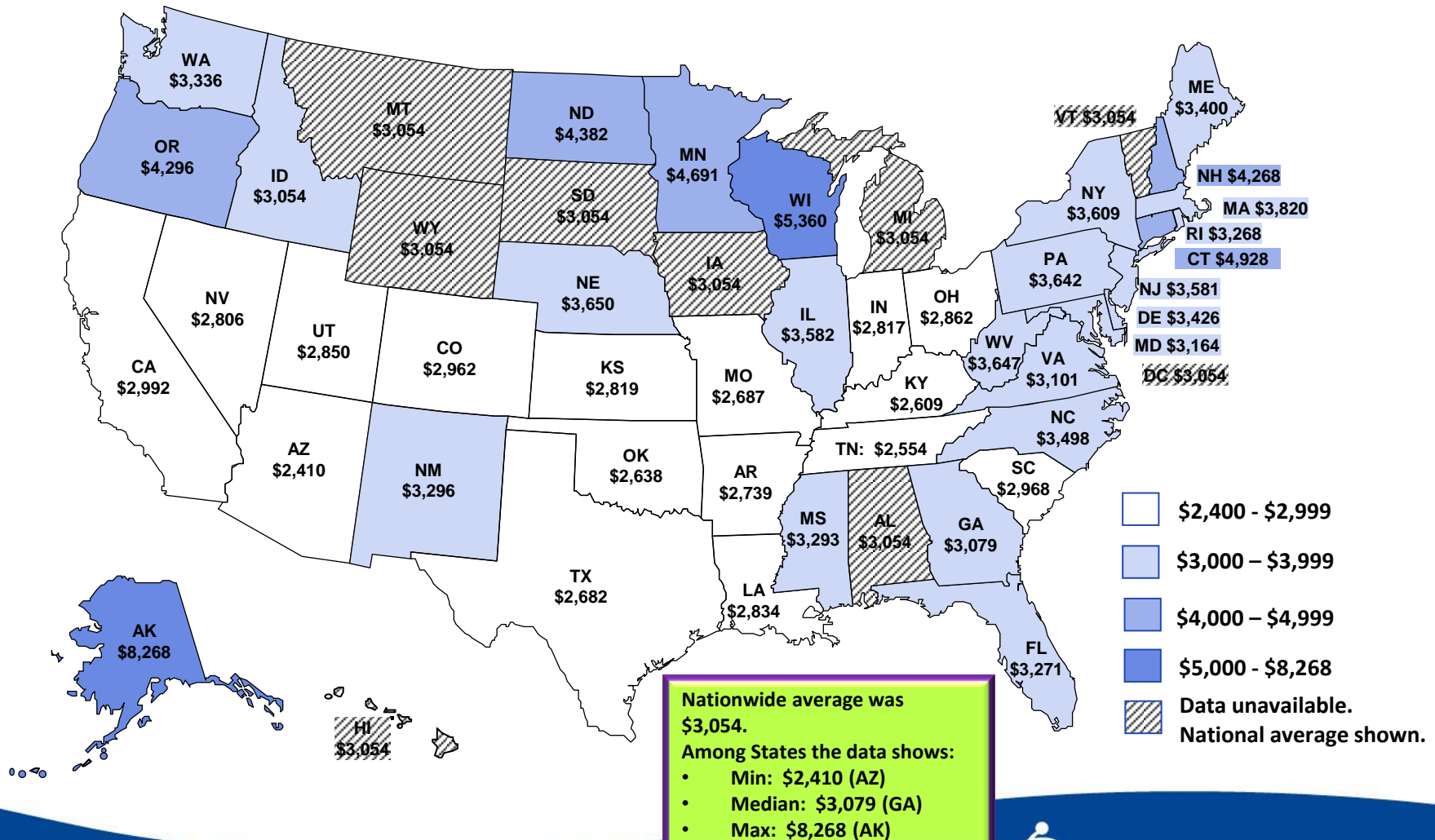


Medicaid Fee-for-Service Reimbursement to CNMs/CMs for Normal Vaginal Delivery (CPT 59400) - 2015



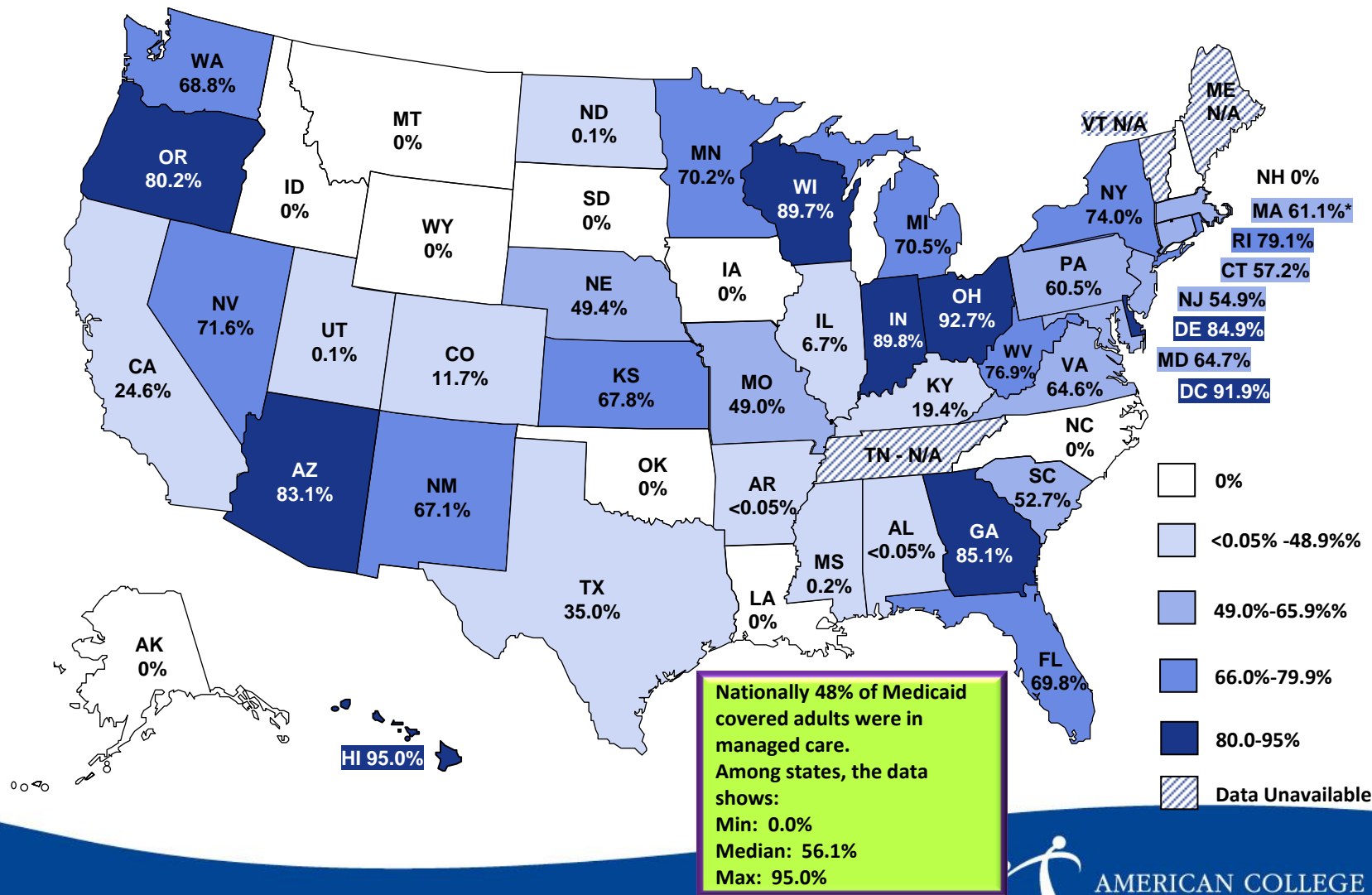
- Medicare pays \$2,167. The median Medicaid payment is \$1,410 – just 65% of Medicare's national payment.
- A midwife in NJ must care for NINE women in order to earn as much as a midwife in AK who cares for ONE.

Percent of Adults with Medicaid Covered Under a Comprehensive Managed Care Plan – FY 2011



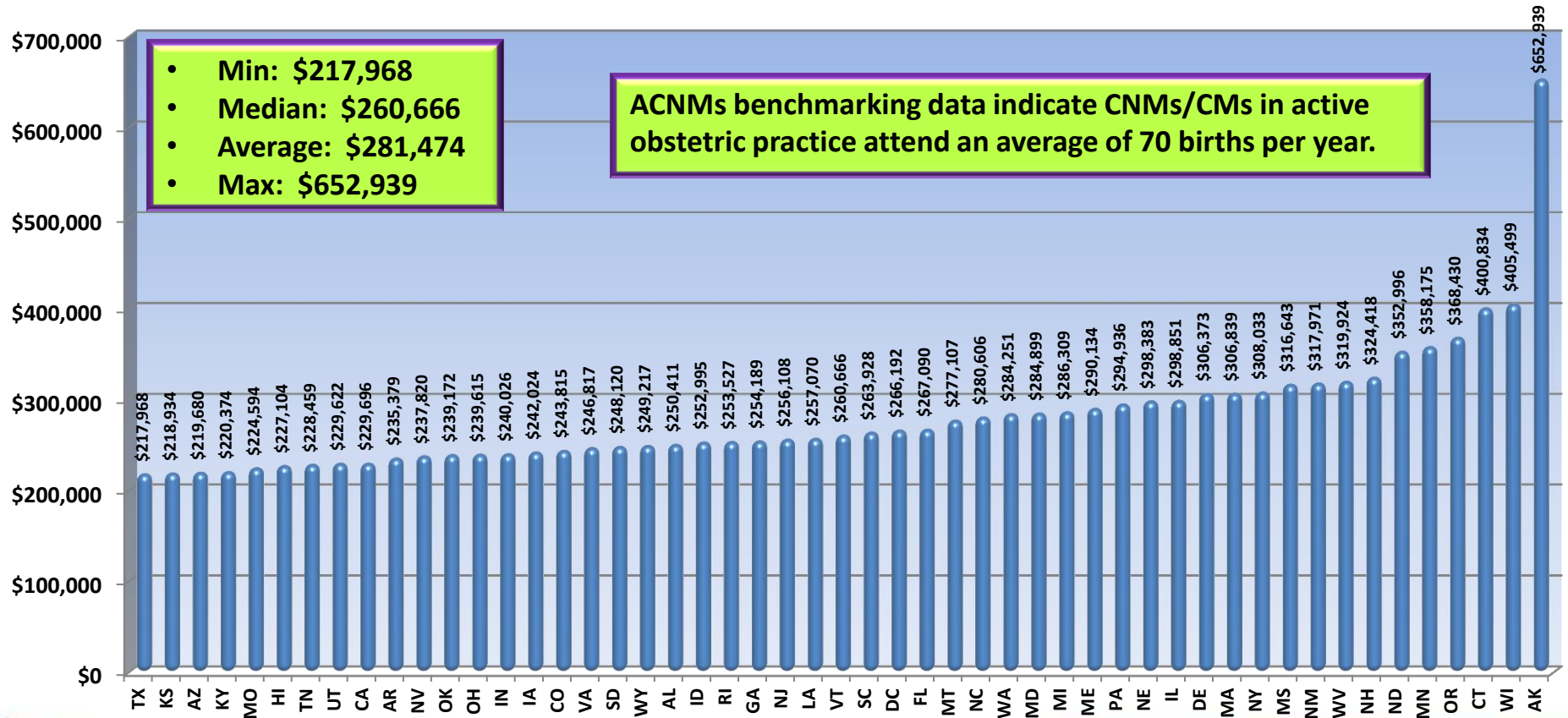

Modeled 2015 CNM/CM Revenue: Assuming 70 Vaginal Births

- Min: \$217,968
- Median: \$260,666
- Average: \$281,474
- Max: \$652,939

ACNMs benchmarking data indicate CNMs/CMs in active obstetric practice attend an average of 70 births per year.



Methodology: 70 births divided into Medicaid and commercial shares, based on % covered by Medicaid in each state. Medicaid and commercial shares of the 70 births multiplied by Medicaid fee-for-service and average commercial payment rate in each state. These two products summed to yield total modeled revenue generated.

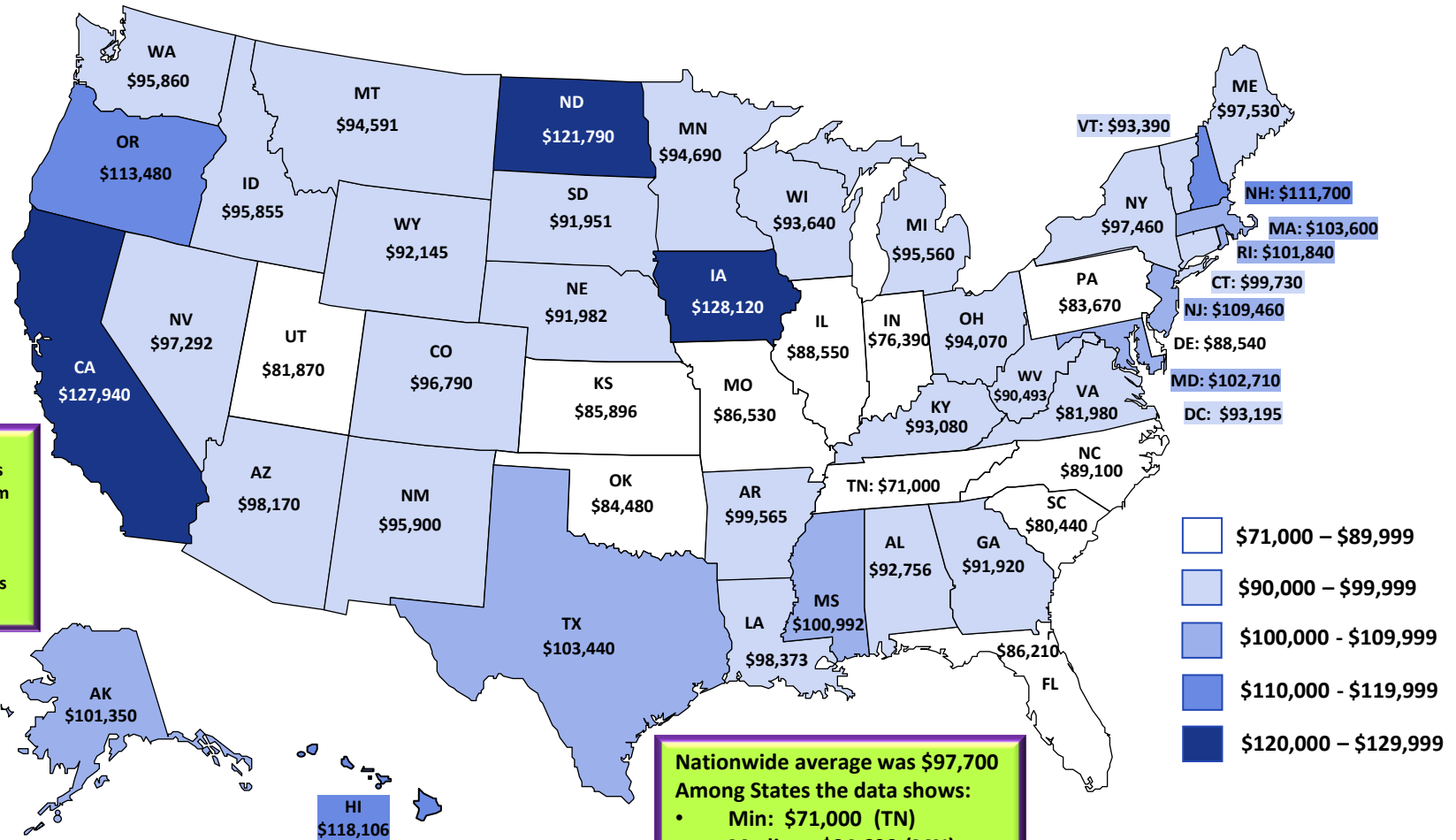

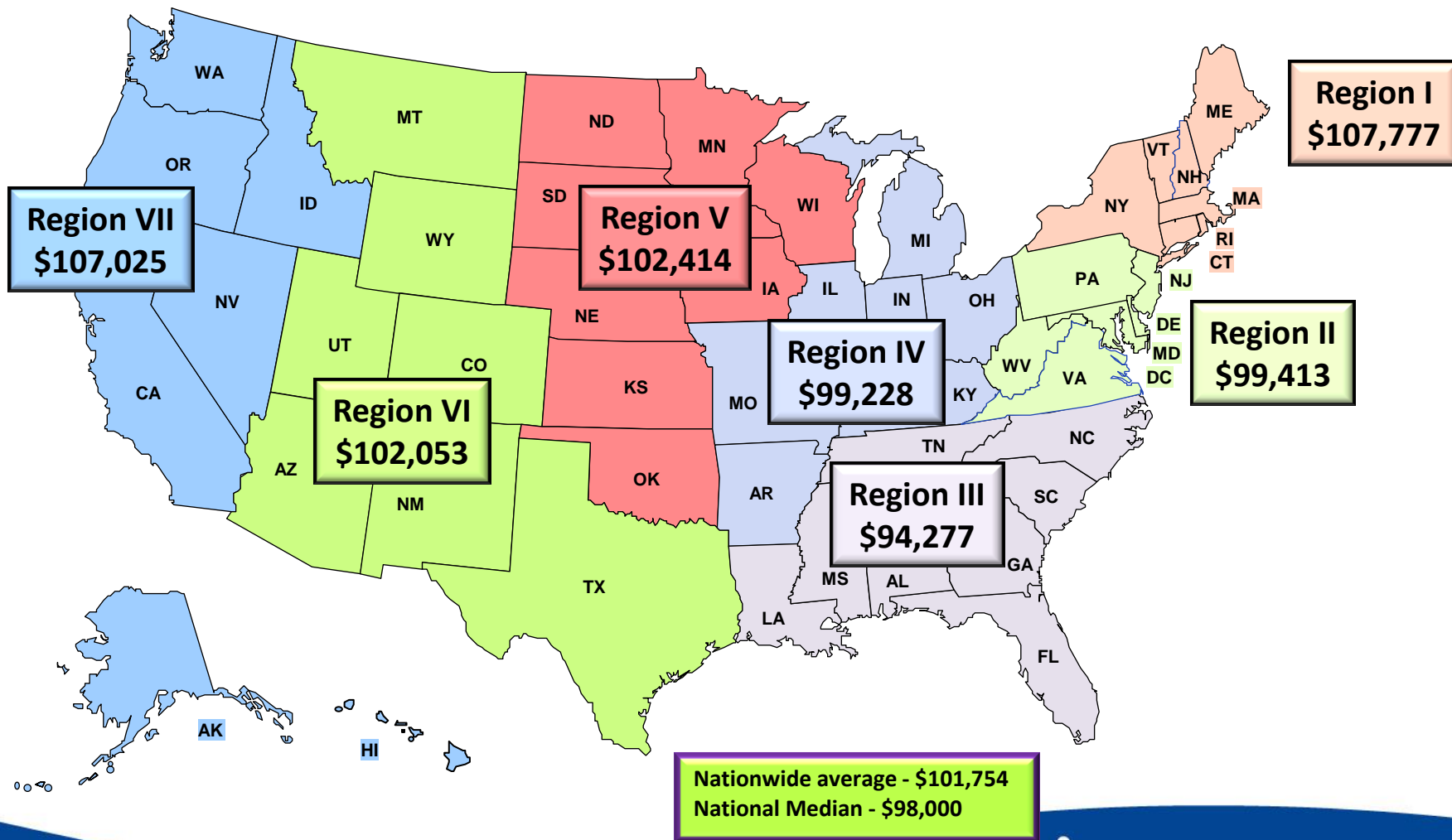

Average CNM/CM Annual Compensation by ACNM Region – ACNM Compensation Survey - 2014



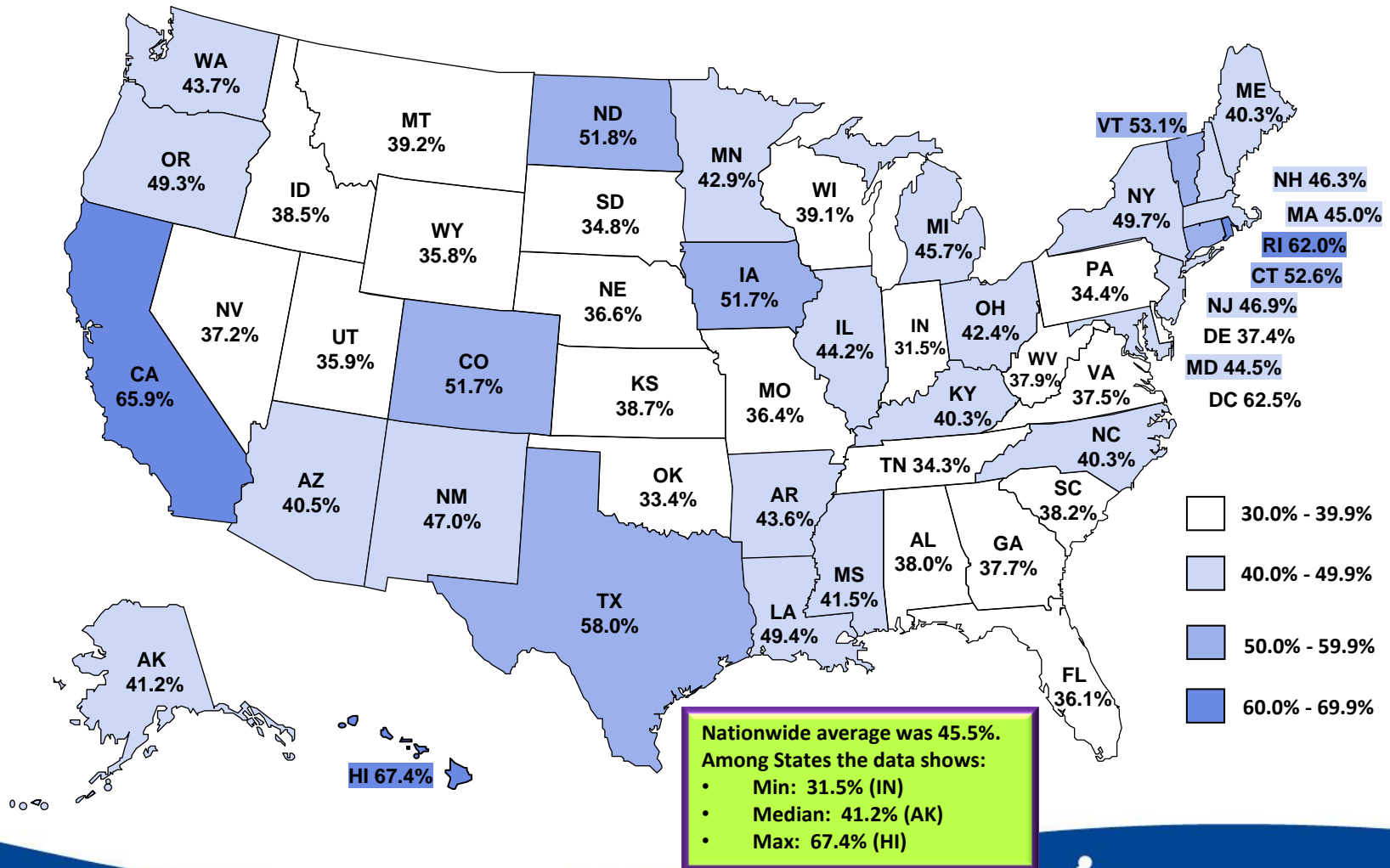

CNM Salary as a Percent of OB Salary – Bureau of Labor Statistics - 2014

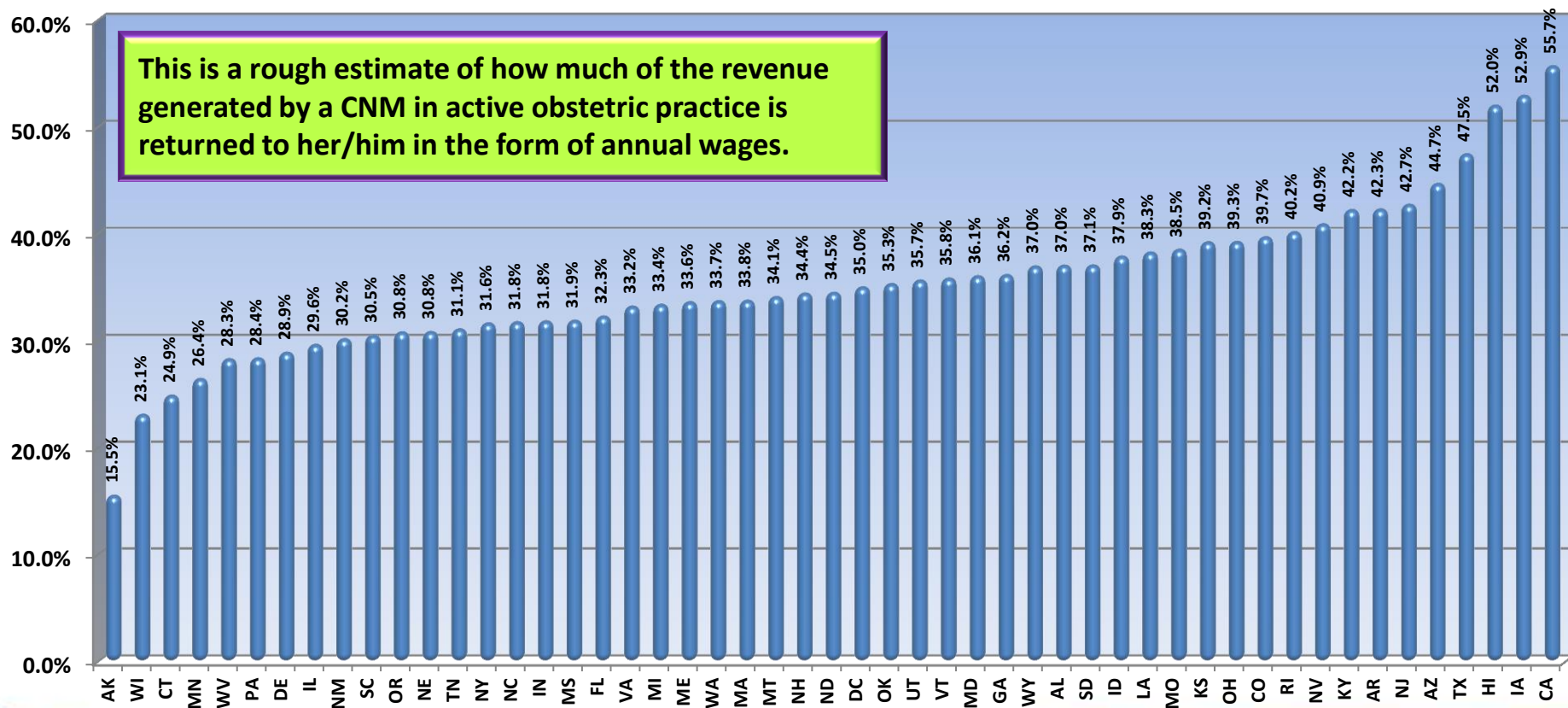
