ACME BOR Seeks a Public Member

The BOR has a great volunteer opportunity for a public member. Please assist me in sharing this opportunity with anyone who may be interested.

The ACME Board of Review (BOR) is seeking an individual to serve as a public member on its Board. The BOR is the unit within ACME whose responsibility is the evaluation of nurse-midwifery/midwifery education programs for the purpose of

granting pre/accreditation status and monitoring the programs' continued compliance with pre/accreditation standards/criteria. The BOR is committed to the consistent application and enforcement of ACME criteria. There are two meetings a year and on average four to six programs to review per

meeting.

Public members are selected based on the following criteria:

- a) Does not derive any income from the practice of midwifery
- b) Commitment to preparation of well qualified health care providers for women and children
- c) Possesses knowledge and skills complementary to the purpose of the BOR
- d) Is familiar with the accreditation process
- e) Has a commitment to attend meetings and conference calls as necessary
- f) Is able to communicate electronically
- g) A person is ineligible to be a public member if she/he has a real or perceived conflict of interest related to the work of ACME.

This includes an individual who is:

1. A CNM/CM
2. An employee of ACNM, AMCB, A.C.N.M. Foundation
3. An employee of ACME, member of the BOC
4. An employee, a member of the governing board, a current owner, shareholder of, or consultant to, an institution or program that either is pre/accredited by ACME or has applied for pre/accreditation
5. A member of any trade association or membership organization related to, affiliated with, or associated with ACME
6. A spouse, parent, child, or sibling of an individual identified in section 1) or 2) or 3) or 4) of this definition.

[Who Defines Expertise?](#) by Collen Flaherty, May 2, 2017, *Inside Higher Education*

Accreditor's new rules are forcing a professor who has taught philosophy for 50 years to stop doing so, because her Ph.D. is in English. Many object. Accreditors sometimes adjust their standards to improve educational quality, and that's what the Higher Learning Commission hoped to achieve by requiring that professors teach only within their fields of expertise, as defined by their advanced degrees. But the recent change raises questions about how to define expertise and how it can be earned – questions that are at the heart of an ongoing debate at Wayne State College in Nebraska.

[Elizabeth Warren to Accrediting Agencies: Step Up](#)

Arguing that millions of federal tax dollars and the futures of low-income students are at stake, Sen. Elizabeth Warren, D-Mass., on Wednesday called for accrediting agencies to play a more active role in fighting fraud, waste and abuse in higher education. Don't sit on your hands as states and the federal government go after schools for fraud," Warren told approximately 400 attendees at the annual conference of the Council for Higher Education Accreditation, or CHEA. Rather, Warren said, accrediting agencies should be more aggressive and work with the federal government to share information and determine if schools are cheating students. "You're supposed to be the ones on the front lines here," Warren said.

[Rubio Reintroduces Accreditation Bill](#)

Senators Marco Rubio and Michael Bennet this week reintroduced a bill that would create an alternative accreditation pathway. The proposed legislation would give previously unaccredited institutions access to federal financial aid under a five-year pilot program. Providers, including new ones, would be eligible for aid through contracts with the U.S. Department of Education, but only if they can demonstrate quality through positive student outcomes, the two senators said in a written statement. Rubio has been both outspoken and in the weeds with his interest in accreditation. During his recent campaign for the Republican presidential nomination, Rubio called the current higher education system a "cartel" he would bust with an alternative accreditation pathway for high-quality, low-cost competitors. The return of the legislation he had proposed with Bennet, a Colorado Democrat, suggests that the Florida Republican will continue to push on the accreditation issue. "America needs a 21st-century higher education system that embraces all the new ways people can learn and acquire skills without having to go the traditional four-year college degree track," Rubio said in the statement. "To modernize our higher education system, we must end the status quo

"To modernize our higher education system, we must create state quality accreditation system, which stifles competition, fuels soaring tuition costs and limits opportunities for nontraditional students, such as working parents. The alternative accreditation system we've proposed is built on higher quality standards and outcomes than the current accreditation system, and would mark an important first step toward shaking up a higher education system that leaves too many people with tons of student loan debt and without degrees that lead to good-paying jobs."

[DeVos Urged to Restore Loan Servicing Protection](#)

130 plus democratic lawmakers called on Education Secretary Betsy DeVos Wednesday to reinstate consumer protections for student borrowers in federal contracts with loan servicers. Democrats, including Massachusetts Senator Elizabeth Warren and Washington Senator Patty Murray, the ranking Democrat on the Senate education committee, said DeVos's decision to rescind the previous guidance raised questions about how the department will hold servicers accountable and protect the rights of borrowers.
