Continued Programmatic Accreditation

• **University of Kansas,** Nurse-Midwifery Program - Doctor of Nursing Practice (DNP) and Post-Graduate Certificate (July 2017 through July 2027)

Substantive Change

• The Ohio State University, Nurse-Midwifery Program – The substantive change was to provide an additional pathway to the M.S. degree for nurse-midwife students by allowing students to take DNP coursework in the nurse-midwifery master's program. The request is to substitute eight doctoral level courses for five master's level core courses. The M.S. midwifery specialty courses and M.S. midwifery clinical courses will remain the same. Accreditation granted July 2017 through July 2024.
