The series will offer five sessions. Sessions 1-4 will examine the ACME Criteria and Session 5 is a workshop devoted to preparation of the ACME SER/PAR. Attend as many sessions as you like or attend the full series. Whether you want to better understand the criteria framework, discover ways to effectively provide evidence that illustrates compliance with criteria or some other aspect, this series is for you!

### **Session 1: Organization & Administration and Faculty**

This interactive session provides an opportunity to review ACME Criterion I: Organization and Administration and ACME Criterion II: Faculty. Led by Dr. Gretchen Mettler, participants will have an opportunity to explore the difference between pre-accreditation and re-accreditation criteria, review the SER/PAR template with expert leadership, discuss appropriate resource documents that address each criterion and develop a draft response for selected criteria. This session is designed to help current and aspiring midwifery programs to more effectively understand and respond to ACME's Criterion I and Criterion II which require information about the program's overall organization, administrative factors and faculty.

### **Session 2: Students**

What does ACME mean by *ensuring programs have well-designed, equitable, transparent and consistently applied student-related policies*? Led by Dr. Debora Dole, this session is designed to answer that question and more. Exploring ACME Criterion III: Students, this session will give participants a chance to better understand the difference between pre-accreditation and re-accreditation criteria, review the SER/PAR template with expert leadership, discuss appropriate resource documents that address each criterion and develop a draft response for selected criteria related to the Criterion III section.

### **Session 3: Curriculum**

Curriculum matters! This interactive session, led by Dr. Debora Dole, is designed to examine ACME Criterion IV: Curriculum. No better place to discuss the difference between pre-accreditation and re-accreditation criteria, review the SER/PAR template with expert leadership, discuss appropriate resource documents that address each criterion and develop a draft response for selected criteria for ACME Criterion IV: Curriculum.

### **Session 4: Resources and Assessment & Outcomes**

As a nationally recognized accrediting agency, ACME requires that programs demonstrate the presence of adequate resources that promote student and faculty success, a comprehensive assessment plan and publicly available outcomes data that show program quality. This two-part session, led by Dr. Debora Dole and Dr. Gretchen Mettler, will explore ACME Criterion V: Resources and ACME Criterion VI: Assessment and Outcomes. The session will include a discussion about the difference between pre-accreditation and re-accreditation criteria, the SER/PAR template and appropriate resource documents that address each criterion. Participants will also have a chance to develop a draft response for selected criteria.

### **Session 5: Writing the Self-Evaluation Report/Preaccreditation Report (SER/PAR)**

This participatory workshop provides a chance for participants to engage in writing to specific criteria, identifying appropriate types of evidence, organization of materials for easy navigation of documents and so much more. From collaborating with colleagues to draft a response to selected ACME preaccreditation or accreditation criteria, using the SER/PAR template and a SER/PAR critique exercise, this workshop is designed to advance your knowledge, skills and abilities related to preparing a SER or PAR.
