### Voting Instructions

Offices up for election in 2020 include Vice President, Region IV Representative, Region VI Representative, Region VII Representative and the yearly candidates for the Nominating Committee. Voting opens March 3-April 4, 2020. Members who have an email address on file at ACNM will receive an email with a link to the secure electronic ballot. Members who do not have an email on file at ACNM will receive online voting instructions via mail.

## **Bylaws 2020 Revision Proposal Voting For SBS System**

Nonprofit bylaws define the structure and function of all areas of the organization. Most nonprofit organizations review their bylaws approximately every 5 years to ensure that their bylaws meet the current needs of the organization, reflect current state and federal laws, and align with best practices in nonprofit governance.

The ACNM Bylaws Committee recently completed a comprehensive review of ACNM's current bylaws. This review process included soliciting input from all areas of the organization, consulting with ACNM's legal counsel, and hosting a comment period for all members in August of 2019. The Bylaws Committee is pleased to propose the final draft of the ACNM Bylaws 2020 Revision proposal to the membership for approval. We ask that you cast **EIGHT (8) SEPARATE** votes:

### **Bylaws Vote #1**

#### **Vote Response Required: Approve/Disapprove**

Bylaws Vote #1 is a vote for approval of the **general revision** in its entirety, with the exception of SEVEN (7) additional provisions which will be voted on separately in Bylaws Votes #2-8 (explanations below). Most of the revisions throughout the ACNM Bylaws 2020 Revision proposal are editorial or clarifying changes to the current bylaws. In addition, the following more substantive revisions are proposed:

- Removal of the mission which is best captured in operational documents such as the Governance Manual;
- The Annual Business Meeting revised to Membership Business Meeting for consistency throughout the bylaws;
- The duration of annual membership was made explicit;
- Verbiage such as "membership card" and "invoices" stricken as both are available electronically online;
- Notice of the Membership Business Meeting and meeting agenda was revised to 21 days to reflect quicker, easier, electronic methods of communication currently utilized;
- That any ACNM member is eligible to attend the Membership Business Meeting was made explicit;
- Language pertaining to affiliate incorporation, responsibility, authority, policies/positions, processes, and membership were clarified;
- The title of Executive Director was revised to Chief Executive Officer to be consistent with the current structure within National Office;
- Language pertaining to and reflecting the current volunteer structure was implemented;
- Language to authorize the Board to fulfill vacancies was added to ensure a full Board;
- Language to reflect board composition was clarified;
- Language to clarify and make explicit processes around meeting of the Board, including the minimum number of Board meetings, who may attend meetings, notice of meetings, and documentation of meeting minutes, was added;
- The role, terms, election, appointment, and resignation processes with regard to the Executive Committee of the Board were clarified;
- The independent status and functioning of the Nominating Committee was clarified and made explicit and membership revised to be consistent with Nominating Committee SROPs;
- With regard to FACNM clarifications were made with regard to dues as separate from the general ACNM budget;
- Language around names, trademarks, intellectual property, etc were clarified to protect their use as well as a potential revenue source; and
- Specific timelines and clarifying language with regard to the budget and audit were specified.

## **Bylaws Vote #2**

### **Vote Response Required: Approve/Disapprove**

**We are asking members to cast a vote on a proposal to allow those in the Student Members membership classification the right to be voting members of ACNM (Article III, section B3).** The Student Member of the Board put forward this proposal as the membership includes a large percentage of students (1/3) the active/life members which they felt justified a change to voting status to “help to address issues of diversity and inclusion, narrow the student knowledge deficit about the ACNM, provide clinical support for students, and offer professional support to new graduates – the main focuses for [the 2019] student report.”

## **Bylaws Vote #3**

### **Vote Response Required: Approve/Disapprove**

**We are asking members to cast a vote on a proposal to remove limitations on increasing the annual membership dues (Article III, section D1).** On the recommendation of legal counsel, this section was reworded to make clear the distinction between National ACNM and ACNM Affiliate dues. Furthermore, on the recommendation of legal counsel and with support of the Board, this amendment was included as a means to avoid locking ACNM into a “no growth” status. The ability to increase dues only to keep up with inflation is effectively a stand-still budget, which only avoids losing buying power, without the ability for any real dollar increase to increase ACNM programs, staff, efforts, etc., except by a member vote which is not ideal for governance.

## **Bylaws Vote #4**

### **Vote Response Required: Approve/Disapprove**

**We are asking members to cast a vote on a proposal to include a new *ELECTED VOTING* member of the Board: the At-large midwife of color (self-identified); to have a term length of 3 years consistent with other elected voting members of the Board (Article IV, section C).** The Board Composition Task Force felt that an elected at-large midwife of color (who would self-identify) could represent midwives of color among the general membership recognizing the need for “more valuable input, wisdom, and voices from people whose communities are most deeply affected by the maternity crisis, at every level of leadership, and in particular, at the highest level of leadership as found on the ACNM Board of Directors.”

## **Bylaws Vote #5**

### **Vote Response Required: Approve/Disapprove**

**We are asking members to cast a vote on a proposal to include a new *APPOINTED VOTING* member of the Board: the Midwives of Color Committee (MOCC) Chair or designee; to have a term length of 1 year with the option for re-appointment up to a maximum of 6 years total (Article IV, section C).** The Board Composition Task Force recommended that the MOCC Chair or their designee, currently an ex-officio *non-voting* member should have a vote as a permanent member of the board. The current MOCC Chair and the Student Member of the Board also endorse this amendment as a valuable way to integrate leadership into the board. The term length has been clarified to include the 3-year term of the MOCC Chair for up to 2 terms as specified in the Division SROPs.

## **Bylaws Vote #6**

### **Vote Response Required: Approve/Disapprove**

**We are asking members to cast a vote on a proposal to include a new *APPOINTED VOTING* member of the Board: the Student Member; to have a term length of 1 year (Article IV, section C).** This section also captures the elevation of the existing student member to voting status and is supported by the Board Composition Task Force and Student Member of the Board given that the large percentage of the membership that is comprised of student members.

### **Bylaws Vote #7**

#### **Vote Response Required: Approve/Disapprove**

**We are asking members to cast a vote on a proposal to include a new *APPOINTED VOTING* member of the Board: the At-large member of the public; to have a term length of 1 year with the option for re-appointment up to a maximum of 6 years total (Article IV, section C).** The Board Composition Task Force recommended the addition of an at-large member of the public who could bring specific needed attributes or skill set determined by the board (e.g. underrepresented group, finance, fundraising, law, marketing).

### **Bylaws Vote #8**

#### **Vote Response Required: Approve/Disapprove**

**We are asking members to cast a vote on a proposal to require that the Nominating Committee present TWO qualified nominees for each elected Board position to the membership (Article XIII (now Article XII in the revision), section A, 1a).** Previously there was no specification allowing for multiple candidates for any given field. Given the findings that emerged prior to the 2019 amendment to the bylaws that revealed low voting participation during elections, Bylaws felt that presenting more than 2 candidates does not yield a clear mandate among the voting majority.

## Candidates for Vice President



**Jessica Brumley, CNM, PhD, FACNM**

**Location: Tampa, Florida**

Jessica Brumley earned her midwifery degree (MA) from New York University in 2001 and her PhD in Nursing from the University of South Florida (2012). She has spent the past 15 years with the University of South Florida, Department of Obstetrics & Gynecology and currently serves as Director of the Division of Midwifery. Under her leadership, the practice has doubled in size and expanded coverage to include a full scope midwifery service with 11 Midwives attending over 1,000 births per year. This practice is known as a model for team-based care in which all members are valued for their unique expertise. She has served ACNM in multiple local, state and national roles. As local chapter chair, she served as a founding member of the Florida Affiliate executive board and currently serves as President. She has focused on growing the volunteer leadership and improving the value of membership. She represents the Florida Affiliate on the Florida Perinatal Quality Collaborative Steering Committee, the ACOG District XII Advisory Council and serves as the Florida Representative to the ACNM AIM State Leaders Workgroup. At the national level, she has served as Secretary of the Midwives of Color Committee and Chair of the Basic Education Section of the Division of Education. She served on the Diversity and Inclusion Taskforce and was the ACNM Representative to the AIM Workgroup that created the Peripartum Racial/Ethnic Disparities Patient Safety Bundle. She has been honored to have been a Sigma Theta Tau Maternal Child Health Leadership Fellow (2010-2011), ACNM Foundation Thatcher Fellow (2012) and has been inducted as a Fellow of the ACNM (2018).



**Michelle Drew, CNM, DNP, MPH, FNP-C, CEFM**

**Location: Wilmington, Delaware**

I believe that serving in elected office of the organization that represents our profession, my vocation should be the duty and right of not just an elitist select few, but of every single member and that The Leadership should look like the people that profession serves. I'm the 7th great-granddaughter of Sarah described by her enslaver as "bit high-minded but a surpassing midwife". I am the great-granddaughter of Stella Smith Marsh, who was among the last Black midwives that caught every Black baby in Bland County and most poor white babies for more than 300 years until 1965. I'm the proud apprentice of the late Ellie Muyumbwa, the Bantu midwives who mentored me into the nurse, midwife, mentor to future midwives I am as a missionary and junior midwife in Zambia. I'm the founder of a Black woman led community based organization fight to save Black mamas and babies I've proudly served as a member of the Mentoring and Archiving subcommittees of the Midwives of Color Committee, pairing mentor-mentee dyads that we will manifest relationships

that tie two generations of nurse-midwives of color together not only through the profession of midwifery, but common ties of culture and community I tell and preserve the history of Black midwives in America I was honored to serve as a reviewer of scholarship applications for the ACNM Foundation. I graduated from one of the most consistently respected and ranked nurse-midwifery programs in the United States, Vanderbilt School of Nursing with a near perfect GPA of 3.997 while working full-time as a nurse and parenting. I've presented and moderated at ACNM annual meeting in workshops, sessions and plenary sessions. I've served underrepresented, disenfranchised women with respect and honor for 20 years. I AM The American College of Nurse Midwives. And I'm my ancestor's wildest dreams.



**Sascha James-Contarelli, CNM, DNP, FACNM**

**Location: New Haven, CT**

I received my bachelor's in nursing from Howard University and my masters in midwifery and doctorate from New York University.

My professional journey has been unique and broad reaching with practice settings in both the public and private sector. In 2005, I became more active in political advocacy and policy to ensure that midwives are recognized as invaluable stakeholders in perinatal care. These experiences cemented my belief in the importance of education which led to my transition to full-time professor in 2014. After serving as the director of a graduate nursing program, I decided to focus more on my passion for midwifery education.

I recently joined the nursing and midwifery faculty at Yale School of Nursing. I am privileged to serve as the president of ACNM's New York State affiliate. ## Candidates for Region IV Representative



**Kathleen Lavery, CNM, MS**

**Location: Jackson, MI**

I have been active in the politics and policy of Nurse- Midwifery since 1991, in local, state and national roles. **Heide Cruikshank, CNM, WHNP, RNC-OB**

**Location: San Francisco, CA**

I am a certified nurse midwife working in San Francisco, CA at UCSF in the Center for Reproductive Health. I primarily see patients who want to build families, but also patients who want to preserve their fertility before undergoing hormonal therapy as part of their gender transition or who require a higher level of care about fertility due to future plans, cancer or PCOS. Before coming to UCSF, I worked in a full scope independent midwife practice in Minnesota at Minnesota Birth Center. I was a student nurse midwife in Oregon. I lived, worked and was a student midwife in Washington. As a nurse in Seattle, I cared for patients who had been airlifted from Alaska. For years prior to that I worked as a nurse in Texas. I have affection for all the areas in Region VII and the only one I haven't visited yet is Alaska - emphasis on YET. I have had the good fortune to work all over the country and I love learning from midwives who practice in different settings. I am an eager communicator and love responsibility so, as representative, I look forward to reporting national issues to my region and vice versa. **Theresa M. Kouadio, CNM, MSN**

**Location: Kotzebue AK**

As we end 2019 and move into 2020, I prepare to celebrate my 25th anniversary as a nurse-midwife. Currently I serve as the Alaska State Affiliate president, and secretary of the APRN Alliance. For the past three years I have had the privilege of living and working inside the Arctic Circle with my amazing wife Charla. As a staff midwife at Maniilaq Health Center I provide care to women and babies of the Northwest Arctic Borough and the village of Point Hope. I was the first nurse selected from Alaska to participate in the prestigious Duke-Johnson & Johnson Nurse Leadership Program completing a project to implement telehealth visits as a part of prenatal care. Caring for the historically disenfranchised has been my career-long vocation, now even more so where providing care is even more difficult due to realities of the inclement arctic weather, geographic isolation, and the vastness of the service area.

As an African-American, same gender loving person I thought I knew firsthand the impact of racism, institutional racism, poverty, and social determinants of health. What I have learned is that these same realities are amplified up here.

In my 25 years, I have served as a midwife in every setting from being one of the early staff midwives of the DC birth center under Ruth Lubic to, rural and regional hospitals in North Carolina and Florida, midwifery education with my wonderful midwifery colleagues at Baystate in Springfield, Massachusetts. I truly understand what it is to be a midwife in every setting.



**Cheri Van Hoover, CNM, MS, FACNM**

**Location: Port Hadlock, WA**

Cheri Van Hoover has been an ardent advocate for women, families, and the profession of midwifery for more than 4 decades, even before becoming a midwife in 1987. A native of Washington State, she lived in California for 32 years, where she received her midwifery education and provided full-scope care for widely diverse populations in varied settings, culminating as assistant clinical professor with the UCSF Faculty OB/GYN Group. Since returning to rural Washington 15 years ago, her clinical practice has focused on outpatient reproductive health and she has served as distance faculty for the Midwifery Institute of Philadelphia University, now Thomas Jefferson University. Her scholarly publications cover diverse topics: health policy education, midwives in politics, midwives as palliative care clinicians, and body art. Cheri's service to ACNM has included the Clinical Practice Committee, Service Director's Network, Membership Committee (Founding Chair), Nominating Committee (elected office), Local Program Committee, Informatics Committee (Founding Member), ACNM Certification Council (Proctor), and Midwives for Universal Healthcare Caucus (Founding Member, Secretary). She has served JMWH since 2001 as editorial board member, contributing editor, and peer reviewer. Honored three times with the ACNM Excellence in Teaching Award, she also received the Philadelphia University Distinguished Adjunct Faculty Award, the JMWH Best Review Article of the Year Award, and is an ACNM Fellow. She received recognition as an Honored Guest Lecturer in Health Policy by Georgetown University's CNM/WHNP program. Cheri's many community activities serve as vehicles for wider recognition of midwifery as a profession and promotion of midwifery values. Currently, these include activism in groups dedicated to reproductive justice and local healthcare access, as well as Friends of the Library, Rotary International, and free instruction in partner dance. She ran for local elective office in 2017, coming within 0.7% of winning a seat on the hospital district board of commissioners.

**Lauren Abrams, LM, CNM, MSN**

**Location: Brooklyn, NY**

Lauren Abrams, LM, CNM, MSN received her midwifery certification and Masters in Nursing at the Yale University School of Nursing in 1993. Her interest in midwifery and - in particular - in working with childbearing families in underserved and immigrant communities was sparked by her work as a counselor in a Planned Parenthood clinic just outside Washington, DC, and two years as a health education volunteer for the US Peace Corps in Mauritania, West Africa. For 26 years, Lauren has worked in both the hospital and birth center settings in New York City, always in facilities that provide care to families affected by poverty, and for the last 6 years held the position of midwifery director of a busy hospital clinic practice. As a white midwife working in communities of color, she believes it is critical to increase the diversity of the midwifery workforce, and feels the nominating committee can play a part in creating an environment at ACNM that helps midwives of all backgrounds feel both welcome and inspired to participate as members. In addition to her clinical work, Lauren has been active at the local and national levels of ACNM. She has served as Nominating Committee Chair and Secretary for the local chapter of NYC Midwives, as a board member of the Midwifery Business Network, and as a member of the ACNM Awards Committee. She received the ACNM Outstanding Preceptor Award in 2011 and 2013.



**Colleen Donovan-Batson, CNM, MS, ARNP**

**Location: Port Angeles, WA**

Colleen is a CNM/NP and midwifery activist with 30+ years of maternal-child healthcare experience. After practicing for years in large county hospital midwifery services in CA, Colleen currently lives in WA, where she has a small homebirth practice. She has served on the faculty of both direct entry and nurse midwifery programs, and as a preceptor for nurse midwifery distance learning programs. She is active in state, national and international midwifery organizations, promoting unity in the midwifery profession.

Colleen's current experience within ACNM includes membership on the Diversity and Inclusion committee, and service on the BIRTH Team, which addresses bias incidents within the organization and at the annual meeting. She also serves on the Home and Birth Center Committee and has participated in the development of interorganizational papers and statements.

**Jessica Ellis, CNM, PHD**

**Location: Salt Lake City, UT**

Jessica Ellis has been a midwife since 2011, spending her career working as both a midwife and a nursing professor. Her training in nursing and midwifery was in Utah.
